# **ROAD TRAFFIC REGULATION ACT 1984**

The A40 Trunk Road (Ealing) Red Route (Clearway) Traffic Order 1995

Notice is hereby given that the Traffic Director for London, following a direction given to him by the Secretary of State for Transport under section 58(1) of the Road Traffic Act 1991 to implement a Trunk Road Local Plan, has made an Order under section 6 of the Road Traffic Regulation Act 1984.

The general nature and effect of the Order will be to introduce new Red Route controls on the A40 Trunk Road in Ealing.

Those controls will include clearway controls prohibiting stopping at any time at locations where stationary vehicles cause danger or congestion at any time. Exemptions to the new Red Route controls will be few but do allow for boarding and alighting from buses, taxis and disabled passengers from disabled person's vehicles.
