#### WATER INDUSTRY ACT 1991: SECTION 19(1)(b)

Consumers in Southall and Stanwell (of North Surrey Water Limited) who may be affected by improvement work being carried out at Ashford Common and Kempton Park Water Treatment Works will wish to be aware of the following information.

Although the water has at all times been, and remains, safe to drink, the Company has found through its water quality monitoring programme that water received from these works, as a bulk supply from Thames Water Utilities, has on occasion not met the standard for pesticides (as required by the Water Supply (Water Quality) Regulations 1989). The Secretary of State, therefore, notified the Company that he will, if necessary, order it to take appropriate steps to ensure that the water supplied will in future meet the required standard.

The Company gave a legally binding undertaking on 16th June 1995, to monitor and facilitate progress of work to be carried out by Thames Water Utilities by 31st June 1996 at Ashford Common and 31st December 1996, at Kempton Park Water Treatment Works.
