PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by ARCO British Limited, whose address is London Square, Cross Lanes, Guildford, Surrey GU1 1UE, for the construction of a 610 millimetre spur pipe-line to tie-in to the East Anglia Gas and Liquids Evacuation System (EAGLES) pipe-line and a 508 millimetre pipe-line and an 88.9 millimetre pipe-line between the Trent and Tyne Platforms. Except with the consent of the Secretary of State, the 610 millimetre and 508 millimetre pipe-lines shall only be used to convey natural gas and the 88.9 millimetre pipe-line shall only be used to convey methanol. The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons. ARCO British Limited has been appointed operator of the pipe-lines.
