Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Shell U.K. Exploration and Production, whose address is Shell-Mex House, Strand, London WC2R ODX, for the construction of a 406.4 millimetre pipe-line and a 88.9 millimetre piggy-backed pipe-line between the Schooner and Murdoch platforms. Except with the consent of the Secretary of State, the 406.4 millimetre pipe-line shall only be used to convey menthanol. The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.
