Notice of application for consent in pursuance of Schedule 10

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991, that an application has been made to the National Rivers Authority, Anglian Region, by Anglian Water Services Limited for consent to discharge trade effluent. The application is for a consent to discharge up to a maximum of 90 cubic metres per day of trade effluent from Ixworth Water Treatment Works, Woolpit Road, Ixworth, Suffolk, into the Sapiston River (Black Bourn) at National Grid Ref. TL93996977. The discharge will consist of filter backwash from a new plant designed to remove iron and manganese from the raw groundwater source. Ixworth Water Treatment Works is within the St. Edmundsbury Borough Council and Suffolk County Council areas.

The Treatment Works is supplied from a groundwater source and produces potable water for the public supply. The uses of the Sapiston River include a Cypinid fishery, moderate amenity, spray irrigation and livestock watering.
