(5) Prohibit any vehicle from proceeding along the length of road specified in Column 1 of Schedule 4 to this notice in a direction other than that specified in relation to that length of road in Column 2 of the said Schedule 4.

The Order will contain provisions for exemptions, to permit waiting by any disabled person's vehicle and for the purposes of picking-up and setting down passengers, loading and unloading goods, enabling a vehicle to be used in connection with a wedding or funeral, and where necessary in connection with the maintenance of the roads and the supply of gas electricity and water.

#### SCHEDULE 1

No Waiting at Any Time in Sides of Roads in Rothley

Fowke Street, north-west side, from a point approximately 11·1 metres west of the junction centre line of "Rothley Brook", an approximately distance of 222·6 metres.

Fowke Street, south-west side, from the Anthony Street junction centre line, in a north-westerly direction to the southern part of the Cross Green junction centre line, an approximate distance of 28.2 metres.

Fowke Street, south side, from a point approximately 38-2 metres east of the Anthony Street junction centre line to a point approximately 66-1 metres east of the Anthony Street junction centre line, a distance of approximately 27-9 metres.

Fowke Street, south side, from a point approximately 82 metres east of the Anthony Street junction centre line to its junction of School Street, an approximate distance of 43.5 metres.

Fowke Street, south-east side, from its junction with School Street junction centre line, in an easterly then north-easterly direction to the centre line of "Rothley Brook", an approximate distance of 212.3 metres.

Homefield Lane, both sides, from its junction with Fowke Street (centre line of "Rothley Brook") in a north-easterly direction for an approximate distance of 12 metres.

Howe Lane, north-east side, from its junction with Woodgate in a southerly direction to its junction with Town Green Street.

Howe Lane, south-west side, from its junction with Woodgate in a southerly direction to its junction with Town Green Street (excluding those parts of Howe Lane, south-west side, referred to in Schedule 3 to this notice).

North Street, both sides, from its junction with Town Green Street (centre line/warning line) in a northerly direction to its junction with Woodgate (centre line/warning line), an approximate distance of 189 metres.

Woodgate, north-west side, from its junction with Westfield Lane, in a north-easterly direction to its junction with Cross Green (excluding that part of Woodgate, north-west side, referred to in Schedule 3 to this notice), an approximate distance of 374.7 metres

Woodgate, south-east side, from a point approximately 49·1 metres south-west of the Howe Lane junction centre line to a point approximately 10 metres north-east of the Howe Lane junction centre line, an overall distance of approximately 59·1 metres.
