# **ROAD TRAFFIC ACTS**

## **AVON COUNTY COUNCIL**

Avon County Council (Wells Road, Totterdown, City of Bristol) (South Eastern Zone) (Reserved Bus Lane) (7 a.m. to 10 a.m.) (No. 3) Order 1996.

Notice is hereby given that on 8th February 1996 the County Council of Avon made an Order under sections 1(1), 2(1) to (3) and 4(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, the effect of which is to prohibit all vehicles other than ambulances in execution of official duties; coaches; emergency vehicles on call in an emergency; pedal cycles; private hire vehicles and taxis complying with the requirements of the relevant licensing authority in respect of roof-top signs and public service vehicles from entering, proceeding or waiting, between the hours of 7 a.m. and 10 a.m., on Monday to Friday (inclusive), in that length of the near side lane of the south-west side of that length of Wells Road (A37), which extends from a point 43 metres south-east of its junction with

Belluton Road to a point 118 metres north-west of its junction with Knowle Road. Vehicles in the bus lane will travel in a north-westerly direction.

Exemptions in the Order are provided for any vehicle to enter, proceed or wait in the bus lane for the removal of any obstruction to traffic; the avoidance of an accident; access to or egress from offstreet loading or garaging; the pursuance of statutory powers or duties or in connection with the supply of gas, water or electricity or of any telecommunication apparatus as defined in the Telecommunications Act 1984 and the boarding or alighting of any person within two minutes.

This Order makes permanent the provisions of the County Council of Avon (Wells Road, Totterdown, City of Bristol) (South Eastern Zone) (Reserved Bus Lane) (7 a.m. to 10 a.m.) (No. 3) Experimental Order 1994 without amendment: The County Council of Avon (Wells Road, Totterdown, City of Bristol) (South Eastern Zone) (Reserved Bus Lane) (7 a.m. to 10 a.m.) (No. 2) Order 1994 as varied is hereby revoked. The County Council of Avon (Motor Cycles in Bus Lanes, City of Bristol) (Variation of Orders) Experimental Order 1995 has been varied by the substitution therein of the said Experimental Order by the above-named Order.

The Order will come into operation on 19th February 1996, and a copy thereof, together with a map, the statement of reasons for making the Order and copies of the Orders to be varied/revoked, may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders Section) during normal office hours.

Any person who desires to question the validity of, or of any provision contained in the Order, on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 as amended, or on the grounds that any relevant requirements of that Act has not been complied with in relation to the Order, may within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.

St. Paul's Churchyard Coach Park-Increase in Parking Charges

Notice is hereby given, that the Common Council of the City of London, propose to make the City of London (Coach Parking Places) (Amendment No. 2) Order 1996, under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.
