

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 7 a.m. and 7 p.m. throughout the week in the lengths or Edensor Road, W.4, specified in the Schedule to this notice and in the first 18.29 metres of Edensor Gardens from its junction with Edensor Road;
- (b) waiting by vehicles for the purposes of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11 a.m. and 6 p.m. on Mondays to Fridays in the streets referred to in paragraph (a) above;
- (c) the sale or offer for sale of goods from a vehicle in the streets referred to in paragraph (a) above will be prohibited unless there is in force a valid licence issued by the Hounslow Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is affected;
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the streets referred to in paragraph (a) above, will be prohibited.

3. The prohibitions referred to in paragraph 2(a) and (b) above will not apply to anything done with the permission or at the direction of a police constable or Council appointed parking attendant in uniform or in certain circumstances, e.g. the picking-up or setting-down of passengers; the carrying out of statutory powers or duties; the taking in or petrol etc. from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply.

4. A copy of the Order, which will come into operation on 19th February 1996, together with a copy of the Order of 1977, and of plans depicting the lengths of road to which the Order relates, can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 6 weeks from the date on which this Order was made, in the Environmental Services Reception Area at the Civic Centre, Lampton Road, Hounslow TW3 4DN.

Any person wishing to question the validity of the Order, or of any provision contained therein, on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, or that any of the relevant requirements thereof, or that any of the relevant regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

SCHEDULE

Proposed waiting restrictions between 7 a.m. and 7 p.m. throughout the week in:

Edensor Road, W.4:

(a) the north-west side:

(i) between the south-eastern kerb-line of Great Chertsey Road and a point 1 metre north-east of the north-eastern kerb-line of the vehicular access to Whittingham Court, Edensor Road;

(ii) between a point 25 metres north-east of a point opposite the party wall of Nos. 20 and 22 Edensor Road and the south-western kerb-line of Grantham Road;

(b) the south-east side:

(i) between the south-eastern kerb-line of Great Chertsey Road and the south-western kerb-line of Promenade Approach Road;

(ii) between a point 25 metres north-east of a point opposite the party wall of Nos. 20 and 22 Edensor Road and the south-western kerb-line of the unnamed road which lies on the south-east side of Edensor Road opposite its junction with Corney Road.

The Hounslow (Corney Road, Chiswick) (Prescribed Route) (No. 2) Order 1996

Notice is hereby given that, the Council of the London Borough of Hounslow, on 12th February 1996, made the Hounslow (Prescribed Route) (No. 2) Order 1996 under section 6 of the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Hounslow (Prescribed Route) Order will be:

(a) to prohibit vehicles the overall width of which together with load (if any) carried thereon exceeds 7 feet proceeding in a south-westerly direction in Corney Road from entering that length of Corney Road which lies between a point 5 metres north-west of the north-western kerb-line of Dartmouth Place and a point 7 metres north-west of that kerb-line;

(b) to require all other vehicles to proceed in that length of Corney Road referred to in (a) above so as to keep both island sites to be constructed therein on the right or offside of the vehicle.

3. Exemption will be provided in the Order:

(a) for vehicles being used for ambulance, fire brigade and police purposes in certain circumstances entering the carriageway between the two island sites to be constructed in the said length of Corney Road from which all other vehicles will be prohibited;

(b) in respect of anything done:

(i) with the permission or at the direction of a police constable in uniform;

(ii) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by the Metropolitan Police.

LONDON BOROUGH OF HOUNSLOW

The Hounslow (Waiting and Loading Restriction) (Amendment No. 88) Order 1996

Notice is hereby given that the Council of the London Borough of Hounslow on 12th February 1996 made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 and Schedule 5 of the Local Government Act 1985, and the Road Traffic Act 1991.

The general effect of the Waiting and Loading Amendment Order will be further to amend the Hounslow (Waiting and Loading Restriction) Order 1977 so that:

(a)(i) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of street specified in the Schedule to this notice;

(ii) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited "at any time" throughout the week on the north-west side of Heathfield Gardens between the south-eastern kerb-line of Heathfield Terrace and a point 6 metres south-west of a point opposite the northern boundary wall of Chiswick Fire Station, Heathfield Gardens;

(b) waiting by vehicles for the purposes of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11 a.m. and 6 p.m. on Mondays to Fridays in the streets referred to in paragraph (a) above;

(c) the sale or offer for sale of goods from a vehicle in the streets referred to in paragraph (a) above will be prohibited unless there is in force a valid licence issued by the Hounslow Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is affected;

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the streets referred to in paragraph (a) above, will be prohibited;
