

(e) the existing restriction on waiting by vehicles in Sutton Lane, Chiswick, between a point opposite the north-eastern wall of Nos. 1 to 10 Arlington Mansions, Sutton Lane, and the northern kerb-lines of Walpole Gardens and Heathfield Terrace be varied to operate between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive.

The prohibitions referred to in paragraph (a) and (b) above will not apply to anything done with the permission or at the direction of a police constable or Council appointed Parking Attendant in uniform or in certain circumstances, e.g., the picking-up or setting-down of passengers; the carrying out of statutory powers or duties; the taking in of petrol etc from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply.

A copy of the Order, which will come into operation on 19th February 1996, together with a copy of the Order of 1977 and of plans depicting the lengths of road to which the Order relates, can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 6 weeks from the date on which this Order was made in the Environmental Services Reception Area at the Civic Centre, Lampton Road, Hounslow TW3 4DN.

Any person wishing to question the validity of the Order, or any provision contained therein, on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

Proposed waiting restrictions between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in:

*Heathfield Gardens, Chiswick*, the south-east side, between its junction with Heathfield Terrace and a point opposite the northern boundary of Chiswick Fire Station, Heathfield Gardens.

*Sutton Lane, Chiswick*:

(i) the south-east side, between the northern kerb-lines of Walpole Gardens and Heathfield Terrace and a point 35 metres north-east of the north-eastern wall of No. 1 Sutton Lane, Chiswick;

(ii) the north-west side, between the northern kerb-lines of Walpole Gardens and Heathfield Terrace and the northern kerb-line of Wellesley Road.

*Walpole Gardens, Chiswick*, between the north-western kerb-line of Sutton Lane, Chiswick, and a point 5 metres north-west of the south-eastern wall of "Ellerslie", Sutton Lane, measured on the north-east side of the road.

*Wellesley Road, Chiswick*, the north-west side, between the north-western kerb-line of Sutton Lane, Chiswick and a point 3 metres north-east of the north-eastern wall of No. 1 Wellesley Road.
