ROAD TRAFFIC ACTS

AVON COUNTY COUNCIL

St. Mark's Road area, Easton, City of Bristol experimental one way traffic orders

Notice is hereby given that on 15th February 1996 the County Council of Avon made the following orders under provisions contained in the Road Traffic Regulation Act 1984 as amended:

1. County Council of Avon (Berwick Road, Easton, City of Bristol) (Eastern Zone) (One Way Traffic) Experimental Order 1996 under section 9 of the said Act, the effect of which, for a maximum period of eighteen months, is to introduce one way traffic working in that length of Berwick Road, Easton which extends from St. Mark's Road to Stapleton Road. Traffic will travel in a westerly direction (i.e. towards Stapleton Road).
2. County Council of Avon (Clare Road, Easton, City of Bristol) (Eastern Zone) (One Way Traffic) Experimental Order 1996 under section 9 of the said Act, the effect of which, for a maximum period of eighteen months, is to introduce one way traffic working in that length of Clare Road, Easton which extends from St. Mark's Road to Stapleton Road. Traffic will travel in a westerly direction (i.e. towards Stapleton Road).
3. County Council of Avon (St. Mark's Road, Easton, City of Bristol) (Eastern Zone) (One Way Traffic) Experimental Order No. 1 1996 under section 9 of the said Act, the effect of which, for a maximum period of eighteen months, is to introduce one way traffic working in that length of St. Mark's Road, Easton which extends from Chester Street to Berwick Road. Traffic will travel in a southerly direction (i.e. towards Berwick Road).
4. County Council of Avon (St. Mark's Road, Easton, City of Bristol) (Eastern Zone) (One Way Traffic) Experimental Order No. 2 1996 under section 9 of and Part IV of Schedule 9 to the said Act, the effect of which, for a maximum period of eighteen months, is to introduce one way traffic working in that length of St. Mark's Road, Easton which extends from Berwick Road to High Street. Traffic will travel in a southerly direction (i.e. towards High Street). An exemption is included to permit fork lift trucks to proceed northwards (contrary to the one way traffic flow) whilst in the process of servicing the Sweet Mart premises and/or the Sweet Mart Warehouse. This order includes the one

way traffic provision already working in that length of St. Mark's Road, Easton which extends from Berwick Road to Henrietta Street by virtue of the County Council of Avon (St. Marks Road and Church Avenue, Easton, City of Bristol) (Eastern Zone) (One Way Traffic) (Prohibition of Driving) Order 1995, traffic already travels in a southerly direction (i.e. towards Henrietta Street) but this length is included so as to give effect to the above exemption.

Note: the introduction of orders numbered 3 and 4 above will effect continuous southbound one way traffic working in St. Marks's Road between Stapleton Road and High Street.

Objections and representations to the experimental orders continuing indefinitely, together with the grounds on which they are made should be sent in writing to the undermentioned address quoting reference NMT/EP/2/194 by 13th September 1996. The County Council of Avon or its successor authority will consider in due course whether the provisions contained in the experimental orders should be continued indefinitely. At that time any objections and comments received will be given consideration. Please note that all representations received may be considered in public by the County Council and that the substance of any representation together with the name and address of the person making it could become available for public inspection.

The orders will come into operation on 11th March 1996 and copies thereof together with a map and a copy of the Council's Statement of Reasons for making the orders may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders Section) during normal office hours and at Eastville Public Library, Muller Road, Eastville, during normal opening hours.

Any person who desires to question the validity of, or of any provision contained in the order on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 as amended, or on the grounds that any of the relevant requirements of that Act has not been complied with in relation to the order, may within 6 weeks after the date on which the order was made, apply to the High Court for this purpose.

Traffic Orders – Kingsmead Square Area, City of Bath

Notice is hereby given that the County Council of Avon proposes to make an order under provisions contained in the Road Traffic Regulation Act 1984 as amended:

1. The County Council of Avon (New Street West, City of Bath) (Prohibition of Driving) Order 199 under sections 1(1) and 2(1) to (3) of the said Act the effect of which will be to prohibit any vehicle entering, proceeding or waiting in the lengths of New Street West specified in the Schedule to this Notice; Exemptions in the order permit any vehicle to enter, proceed or wait in the said length of road in connection with building operations, the removal of obstruction to traffic, maintenance of the road; the supply of gas, water or electricity; the pursuance of statutory duties or for police, fire brigade or ambulance purposes in an emergency.
2. The County Council of Avon (City of Bath) (Central Area) (General Traffic Regulation) (Consolidation) (Variation No. 7) Order 199 under sections 1(1), 2(1) to (3), 4(2) of Part IV of Schedule 9 to the said Act the effect of which will be to vary further the County Council of Avon (City of Bath) (Central Area) (General Traffic Regulation) (Consolidation) Order 1988 so as:
 - (a) to revoke the one way traffic working and waiting restrictions in New Street West consequent upon item 1 above;
 - (b) to introduce one way traffic working in the length of Trinity Street which extends from the road on the north side of Kingsmead Square and the Unnamed road between Trinity Street and Kingsmead Car Park. Traffic will travel from north to south (i.e. towards James Street West or the unnamed road between Trinity Street and Kingsmead Car Park); and
 - (c) to prohibit any vehicle waiting at any time in the whole length of the unnamed road between Trinity Street and Kingsmead Car Park (both sides).
3. The County Council of Avon (Residents' and Card Controlled Parking, City of Bath) (Variation No. 8) Order 199 under sections 45, 46, 49, 51 and 53 of and Part IV of Schedule 9 to the said Act the effect of which will be to vary further the County Council of Avon (Residents' and Card Controlled Parking, City of Bath) Order 1987 so as:
 - (a) to remove the street parking places in New Street West and Trinity Street; and
