Notice of application for consent for the purposes of section 88

Notice is hereby given in accordance with Schedule 10 of the above Act, that an application has been made to the National Rivers Authority by Severn Trent Water Limited for consent to discharge up to 11,514 cubic metres (5,574 cubic metres under dry weather flow conditions) per day of treated sewage effluent and settled storm sewage for flows in excess of 133.3 litres per second (11,514 cubic metres per day) to the River Severn estuary at National Grid Reference SO 6367 0055 from Lydney Sewage Treatment Works, Harbour Road, Lydney, Gloucestershire.

This application has been made in order to comply with statutory requirements outlined in the Urban Waste Disposal Treatment Directive 1991 (UWWTD), and the Works is to be extended to provide biological treatment of the sewage effluent up to the volumes stated above. Currently, the Works only provides initial settlement of the sewage effluent prior to discharge (up to 4,200 cubic metres per day under dry weather flow conditions) and, if this application is granted, the existing consent will be revoked.

ELECTRICITY ACT 1989

Notice under Section 11(2) of the Electricity Act 1989

The Director General of Electricity Supply (hereinafter referred to as "the Director") pursuant to section 11(2) of the Electricity Act 1989 (hereinafter referred to as "the Act") hereby gives notice as follows:

- (a) He proposes to modify the conditions of the Licence granted to SEEBOARD plc under section 6(1)(c) of the Act by inserting new Conditions 2A (restriction on activity and financial ring fencing) and 2B (availability of resources) and by amending Conditions 1 (definitions), 27 (disposal of assets) and 28 (provision of information to the Director);
- (b) He proposes these modifications because the majority of the shares in the company holding the licence is now held by another company;
- (c) In summary, the effect of the modifications is:
- (i) with small exceptions, to limit the Licence holder's business to the supply and distribution of electricity:
