LONDON BOROUGH OF REDBRIDGE

The London Borough of Redbridge, Mews to the Rear of Cameron Road/High Road, Seven Kings and High Road, Ilford—Waiting Restrictions Traffic Orders 1996.

Notice is hereby given that the London Borough of Redbridge, after consulting the Commissioner of Police of the Metropolis made the above-mentioned Orders under sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, on 19th February 1996.

The general effect of both Orders will be to further amend the Redbridge (Waiting Restrictions) Order 1993:

- (i) *High Road, Ilford*: to introduce restrictions on the south-east side of the High Road, north-east for a distance of 28 metres from the north-eastern kerb-line of the access road to Cricklefields Car Park to improve the sight lines for vehicles emerging from Cricklefields Car Park;
- (ii) *Mews to the rear of Cameron Road/High Road, Seven Kings*: to introduce "at any time" restrictions on the north side of the mews in St. Albans Road and on the south side of the entrance to the mews to overcome obstructions by parked vehicles and to improve access.

The Order affecting High Road, Ilford, will come into operation on 11th March 1996.

The Order affecting the Mews to the rear of Cameron Road/High Road, Seven Kings, will come into operation on 1st April 1996.
