4. Prohibit waiting at any time on those sections of road stated in Schedule 7 of the Order and consisting in summary of the following streets:

. Revoke, in consequence of the above, parts of "The Borough of Gillingham (Consolidation of Waiting Restrictions) Order 1972" and "The Gillingham Borough Council (Street Parking) (Disabled Persons Parking Places) Order 1992" within the Controlled Parking Zone.

6. Provide that any person who, whether being the driver of a vehicle or not, contravenes or fails to comply with any provision of this Order shall by section 11 of the Road Traffic Regulation Act 1984, be guilty of an offence and shall be subject to the penalties as set out in Schedule 2 of the Road Traffic Offenders Act 1988.

7. Provide that any driver and the owner of any vehicle (other than solo motorcycle) not displaying in a conspicuous position a valid permit and parked in the length of road specified in the Order for more than one hour or having returned within two hours of departure will be liable to pay an excess charge of £50 (reduced to £20 if it is paid within 7 days of issue).

8. Authorise the issue of excess charge tickets in respect of those vehicles committing the offence in (7) above.

9. Authorise the Council to issue additional Visitors "Day Vouchers" to the residents as part of the residents parking scheme at a cost of £0.50 each.

The Order will come into effect on 4th March 1996 and after it has been in force for an initial period of six months, consideration will be given to continuing it in force indefinitely.
