EAST SURREY WATER PLC

WATER INDUSTRY ACT 1991, SECTION 20

The following notice effects consumers of East Surrey Water Plc in the Horley, Reigate, Edenbridge, Lingfield and surrounding areas in zones supplied by Bough Beech Water Treatment Works.

East Surrey Water Plc has failed to effect the removal of halomethanes from the chlorinated water at Bough Beech Works by using a suitable treatment by 31st December 1995, and the Secretary of State for the Environment has proposed to require completion of a suitable treatment process, namely aeration, which is fully operational, within 28 days.

Nevertheless the water has at all times been, and remains, safe to drink.

EAST SURREY WATER PLC

Notice under section 20, Water Industry Act 1991

The Secretary of State for the Environment hereby gives notice as required by section 20(1) of the Water Industry Act 1991, to East Surrey Water Plc "the Company" that:

- (1) he proposes to make a Final Enforcement Order under section 18 of the Water Industry Act 1991, requiring the Company within 28 days of the date of the Order to effect the removal of halomethanes from chlorinated water at Bough Beech Works by using a suitable treatment process, namely aeration, which is full operational;
- (2) the proposed Order is made for the purpose of securing compliance with Regulation 3(3)(e) of the Water Supply (Water Quality) Regulations 1989 "the 1989 Regulations", and with an Undertaking given by the Company on 15th January 1990, under section 20 of the Water Act 1989, now section 19 of the Water Industry Act 1991, "the Undertaking", that halomethanes would be removed from chlorinated water at Bough Beech Works, by using a suitable treatment process, by 31st December 1995;
- (3) at the site identified in the Order, namely the Bough Beech Works, the Company had, as at 12th February 1996, failed to effect the removal of halomethanes as required by the Undertaking;
- (4) the Company has advised the Secretary of State that suitable treatment plant for the purpose stated in the Undertaking may not be operational before 31st March 1996, and that in the
