To continue for the duration of the undertaking. The information to be provided quarterly, within 28 days of the end of the quarter, or, in the case of a marked increase in concentration or the identification of a pesticide not previously present, as far as it is reasonably practicable, within 28 days of the sample being taken.

- (b) Installation of treatment plant:
- (i) Construction and commissioning of treatment plant. To be completed by 31st December 1996.

 - (ii) Carry out further sampling, and, if investigations show that pollution is of a long-standing nature, consider the temporary provision of an alternative supply of potable water. To be completed as necessary.

Is satisfied that Thames Water Utilities Limited has given and is complying with an undertaking to take all such steps as appear to the Secretary of State for the time being to be appropriate to secure or facilitate compliance with the requirement of Regulation 3(3)(c) of the Water Supply (Water Quality) Regulations 1989.

The Secretary of State is satisfied that the Company is complying with this agreement and has informed the Company that he is satisfied by serving on them the notice printed below.

 - (f) At six-monthly intervals report to DWI on progress with the programme of work covered by this undertaking; first report to be provided on 31st December 1995.
