- (2) 7/34/4/G/76 to abstract water from the chalk strata at National Grid Reference TG 0080 4305, at Morston, in the district of North Norfolk, in the county of Norfolk.

NATIONAL RIVERS AUTHORITY—ANGLIAN REGION

Notice of application for consent in pursuance of Schedule 10

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991, that an application has been made to the National Rivers Authority, Anglian Region by Anglian Water Services Limited, for consent to discharge sewage effluent. The application is for a Consent to Discharge up to a maximum of 64,800 cubic metres per day of fully treated sewage effluent and 17,280 cubic metres per day of storm sewage from King's Lynn Sewage Treatment Works, Clenchwarton, Norfolk, into the Tidal River Great Ouse, at National Grid Reference TF 6057 2225 with a dry weather flow of 21,600 cubic metres per day.

This proposal is for an extensive scheme to refurbish the King's Lynn Sewage Treatment Works. Currently sewage that has received primary settlement only, is discharged on the ebb tide. In addition to this stage the new works will treat flows up to 64,800 cubic metres per day by secondary biological treatment using the activated sludge method, final settlement and ultraviolet disinfection. Settling tanks will receive storm sewage in excess of these flows. In view of the substantial predicted improvement in effluent quality provided by full treatment, application is made to discharge on all tidal states. No increase in dry weather flow is proposed.

King's Lynn Sewage Treatment Works is within the Borough of King's Lynn and West Norfolk and Norfolk County Council areas.

The Tidal River Great Ouse has the recognised uses of basic amenity, habitats for aquatic life, a route for migratory fish and commercial shellfisheries.
