

- (c) provide that the business parking places in Chase Green and River Front will operate between 8 a.m. and 6.30 p.m. Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (d) specify that the vehicles which may be left in the business parking places shall be those displaying a valid business permit issued by the Borough Council or its authorised agent under the provisions of the Enfield (Business Parking Places) (Enfield Town) (Special Parking Area) (No. 1) Order 1994;
- (e) provide that the charge for the issue of a business permit will be:
- (i) £90 and which will be valid for a period of 3 months running from the beginning of the month in which it first becomes valid; or
- (ii) £348 and which will be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (f) contain similar provisions to those set out in paragraph 3(g) above.
5. The general effect of the Free Parking Places Order will be to:
- (a) designate a free parking place in the service road fronting Nos. 43 to 63 Baker Street in which vehicles authorised by the Order may be left for any period without charge;
- (b) provide that the parking place will operate between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (c) specify, in respect of the parking place, that passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles or invalid carriages may be left therein;
- (d) contain similar provisions to those set out in paragraph 3(c) and 3(g) above.
6. The general effect of the Disabled Persons Free Parking Places Order will be to:
- (a) designate a disabled person's parking place in St. Andrew's Road in which vehicles authorised by the Order may be left for any period during the permitted hours without charge;
- (b) provide that the disabled persons parking place will operate at any time;
- (c) specify, in respect of the disabled persons parking place, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly known as "the Orange Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982 may be left therein; and
- (d) provide that certain vehicles may wait in the parking place in certain circumstances, e.g. to allow persons to board or alight (maximum two minutes), to load or unload (maximum 20 minutes), etc.
7. The restrictions imposed by the Enfield (Waiting and Loading Restrictions) (Special Parking Area) Order 1994 will apply to any area previously designated as a parking place and not redesignated as such, as they apply in the immediate vicinity.
8. The effect of the Waiting and Loading Restriction Order will be further to amend the Enfield (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that—
- (a) the hours during which the existing prohibition applies on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that it will apply:
- (i) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive, in the length of street specified in Schedule 1 to this notice;
- (ii) between 10 a.m. and 11 a.m. and between 2 p.m. and 3 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 2 to this notice;
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be changed so that it will apply:
- (i) between 4.30 p.m. and 6.30 p.m. Mondays to Fridays inclusive, in the length of street referred to in sub-paragraph (a)(i) above;
- (ii) between 2 p.m. and 3 p.m. Mondays to Saturdays inclusive, in the length of street referred to in sub-paragraph (a)(ii) above.
9. The Parking Places Orders will come into operation for the purposes of the marking on the carriageway of parking spaces and the placing of traffic signs, etc., on 8th April 1996, and for all other purposes on 15th April 1996. The Waiting and Loading Restrictions Order will come into operation on 15th April 1996.

10. A copy of each of the Orders, of the Enfield (Residents' Parking Places) (Enfield Town) (Special Parking Area) (No. 1) Order 1994, the Enfield (Business Parking Places) (Enfield Town) (Special Parking Area) (No. 1) Order 1994, the Enfield (Free Parking Places) (Enfield Town) (Special Parking Area) (No. 1) Order 1994, the Enfield (Free Parking Places) (Disabled Persons) (Enfield Town) (Special Parking Area) (No. 1) Order 1994 and the Enfield (Waiting and Loading Restriction) (Special Parking Area) Order 1994 (and of the Orders which have previously amended or applied those Orders), of maps indicating the location and effect of the proposed Orders and of the Council's statement of reasons for proposing to make the Orders can be inspected at the Reception Desk, "B" Block, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, during normal office hours on Mondays to Fridays inclusive, until the end of 6 weeks from the date on which the Orders were made.

11. Copies of the Orders may be obtained from the Traffic Engineering Group, Borough Engineer's Department, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD.

12. Any person desiring to question the validity of any of the Orders, or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof, or of any relevant regulations made thereunder has not been complied with in relation to any of the Orders, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

#### SCHEDULE 1

*Change of waiting restrictions: from 8 a.m. to 6.30 p.m. on Monday to Saturday, to between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. Monday to Friday.*

*Chase Side, Enfield, the west side, between a point 20 metres north of the common boundary of Nos. 2D and 2E Chase Side and a point 40 metres north of that common boundary.*

#### SCHEDULE 2

*Change of waiting restrictions: from 8 a.m. to 9.30 a.m. and 4.30 p.m. to 6.30 p.m. Monday to Saturday, to between 10 a.m. and 11 a.m. and between 2 p.m. and 3 p.m. Monday to Saturday.*

*Southbury Road, the south side of the service road fronting Nos. 6 to 14 Bovril House, Colman Parade, between a point 4.57 metres east of the eastern kerb-line of the western rear car park exit road and a point 4.57 metres west of the west side of the eastern rear car park entrance road.*

NOTE. The Council gave notice of its intention, on 31st January 1996, to extend the Enfield Town Controlled Parking Zone into additional parts of Burleigh Road, Halstead Road and Seaford Road, to amend Residents', Business, Free and Disabled Persons' parking facilities in the zone and to vary waiting restrictions in certain streets. Further to objections received in respect of the proposals for Burleigh Road, Halstead Road and Seaford Road and the change of waiting restrictions in Chase Green Avenue, an Order has been made at this stage only in regard to all other proposals as shown above.

*The A4 Trunk Road (Hillingdon) Red Route (Side Roads) Experimental Traffic Order 1996*

*The A40 Trunk Road (Hillingdon) Red Route (Clearway) (Side Roads) Traffic Order 1996*

Notice is hereby given that Hillingdon Council on 2nd April 1996 will make the above-named Orders which will prohibit stopping on the lengths of roads listed below during the hours shown.

The provisions of the experimental Order shall come into operation on 4th April 1996.

The period of the experiment may extend to 18 months and any observations on its provisions should be made to the Divisional Director Transportation, 3S/03, the Civic Centre, Uxbridge, Middlesex UB8 1UW, within 6 months of the date on which the scheme came into operation.

The provisions of the A40 Trunk Road Order shall come into operation on 4th April 1996.
