### ISLE OF WIGHT COUNCIL

*The Isle of Wight Council (Various Streets, Isle of Wight) (Twenty-four hour Main Carriageway Clearway) Order No. 1 1996.*

Notice is hereby given that the Isle of Wight Council in exercise of their powers under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1984, and after consultation with the Chief Officer of Police propose to make an Order the effect of which will be as follows:

1. To revoke

- (i) The County Council of Isle of Wight (A3055 Military Road, Freshwater/Brook, IW) (Twenty-four hour Main Carriageway Clearway) Order No. 1, 1985.
- (ii) The Isle of Wight County Council (A3020 Cowes Road/A3054 Medina Way/St. Georges Way/St. Georges Approach/Fairlee Link Road, Newport, IW) (Twenty-four hour Main Carriageway Clearway) Order No. 1, 1992.

2. To re-enact the provisions contained in the above Order subject to the following amendments:

The implementation of a twenty-four hour main carriageway clearway for A3020 Newport Road, Cowes, from the junction with Nodes Road, Cowes, to the junction with Three Gates Road, Cowes.

The Order is designed to reduce congestion and delay in the said roads and to facilitate the free flow of traffic generally in the promotion of road safety.

A copy of the draft Order, this notice and the relevant plan may be inspected between normal office hours at the Customer Service Centre, County Hall, Newport, Isle of Wight, during the objection period. If you wish to object to the proposed restrictions contained

### ISLE OF WIGHT COUNCIL

*The Isle of Wight Council (Parking Places) Order No. 1, 1996*

Notice is hereby given that the Isle of Wight Council propose to make an Order under sections 32(1), 35(1) and (3), and 45(1) and (2) of the Road Traffic Regulation Act 1984, as amended by the Parking Act 1989, and Part IV to Schedule 9 of the Act as amended by the Road Traffic Act 1991 and under section 13 of the Isle of Wight Act and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act.

The Order revokes the Isle of Wight Council (Parking Places) Order No. 1, 1995. The provisions of that Order are re-enacted subject to the following amendments:

(a) The definition of "summer period" for the purposes of charges be 1st April to 31st October throughout the Order.

(b) The following parking places be designated medium stay between the hours of 8 a.m. to 8 p.m. with charges up to 1 hour 30p, 1 to 2 hours 40p, 2 to 3 hours 60p and 3 to 4 hours 80p (parking permits will not be valid in these):

Moa Place, Freshwater  
Hearn Street, Newport  
Sea Street, Newport  
Garfield Road, Ryde

(c) The parking place at Vernon Meadow, Shanklin to be designated medium stay between the hours of 8 a.m. to 6 p.m. with the charges up to 1 hour 30p, 1 to 2 hours 40p, 2 to 3 hours 60p and 3 to 4 hours 80p and any visit between 6 p.m. and 10 p.m. 80p.

(d) The maximum stay at Park Road, Cowes; Well Road, East Cowes and River Road, Yarmouth to be increased to 72 hours and that at St. Thomas' Street, Ryde and Upper and Lower Coppins Bridge, Newport be amended to 24 hours.

(e) Charging be introduced for parking on Sandown and Shanklin Esplanades between 1st April and 31st October between the hours of 10 a.m. and 6 p.m., maximum 4 hours wait, with the following charges:

Up to 1 hour 30p  
1 to 2 hours 40p  
2 to 3 hours 60p  
3 to 4 hours 80p

and that these also be implemented in respect of the existing pay and display area at the Canoe Lake, Ryde, and the off-street parking place at the Blue Lagoon, Sandown. These charges will apply all the year round on The Parade, Cowes between 10 a.m. and 6 p.m. Parking permits will not be valid at these sites.

(f) The parking places at Appley Park, Ryde, St. Helens Duver and County Hall, Sea Street, Newport be included in the Schedule of parking places where no charge is made.

(g) The parking place at Spa Site, Esplanade Shanklin be amended so that no heavy vehicles are able to use the parking place between 10 a.m. and 6 p.m.

(h) The charging hours for the Botanic Gardens, Ventnor being amended from 8 a.m. to 6 p.m. and 10 a.m. to 6 p.m. and that this be designated a long stay car park during the summer season.

(i) A requirement for any vehicle in a parking place to have an MOT and certificate of insurance.

(j) New three day and four day visitor tickets to be introduced at a cost of £4 and £5 respectively for motor vehicles and £12.50 and £15.00 respectively for Public Service Vehicles.

(k) The period of waiting for Public Service Vehicles and Heavy Goods Vehicles be amended to have charging bands of not less than 4 hours and over 4 hours.

(l) The excess charges be amended to £20 if paid within 7 days and £30 if paid within 8-14 days for motor vehicles and £35 if paid within 7 days and £50 if paid within 8-14 days for HGVs and PSVs.

The effect of the proposed Order will be to revise arrangements for parking at the various parking places throughout the Island and to rationalise the management of these. Additionally, the Order has been amended for easier reference purposes.
