COAST PROTECTION ACT

BLYTH VALLEY BOROUGH COUNCIL

Notice is hereby given that the Borough of Blyth Valley, acting in their capacity as a coast protection authority, under subsection (i) of section 5 of the above Act propose to carry out coast protection works as described herein at Beach Way, Blyth, Northumberland.

The work will consist of a mass concrete sea defence wall, 28 metres in length, 2 metres above beach level, with a pre-cast concrete apron.

The estimated cost of the work is £60,000-00.
