## TOWN AND COUNTRY PLANNING ACT 1990

*Proposed Stopping-up of a Highway at Altrincham*

The Secretary of State for Transport hereby gives notice that on the application of J. Sainsbury plc, he proposes to make an Order under section 247 of the above Act, which will authorise the stopping-up of a length of Rigby Street, Altrincham, being the turning head on the south-easterly side of Rigby Street starting at a point 35 metres from its junction with Oxford Road and extending south-eastwards for 25 metres.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to J. Sainsbury plc by Trafford Metropolitan Borough Council on 2nd February 1996, under reference H41092.

## HIGHWAYS ACT 1980

*The Gloucestershire County Council (A38 Tewkesbury Eastern Relief Road, Classified Road) (Side Roads) Order 1995*
