#### The M6 Motorway (Carlisle to Guards Mill Section, Supplementary Side Roads) Order 19

The Secretary of State for Transport hereby gives notice that he proposes to make the above Order in relation to the M6 Motorway in the District of Carlisle, County of Cumbria, under section 18 of the Highways Act 1980, and all other powers enabling him in that behalf, which will authorise him to stop up the whole length of the highway known as the U1071, from the western boundary of the A74(T) to its junction with the C1015, in the District of Carlisle in the county of Cumbria, and in the vicinity of the route of the Motorway mentioned above.

Copies of the draft Order and the plan referred to in it, and of the M6 Motorway (Carlisle to Guards Mill Section and Connecting Roads) Scheme 19 ; the M6 Motorway (Carlisle to Guards Mill Section, Todhills Services Slip Roads) Scheme 19 ; the Glasgow to Carlisle A74 Trunk Road (Mossband to Todhills) (De-trunking) Order 19 ; the M6 Motorway (Carlisle to Guards Mill Section, Appropriation) Order 19 ; the M6 Motorway (Carlisle to Guards Mill Section, Side Roads) Order 19 and the M6 Motorway (Carlisle to Guards Mill Section) Compulsory Purchase Order (No. ) 19 , each with its accompanying plans together with a copy of the environmental statement for the Scheme, have been deposited and may be inspected, free of charge, during normal working hours from 19th April 1996 to 31st May 1996, or within 6 weeks of the date of first publication of this notice, if that period expires later, at the offices of The Scottish Office Development Department. Victoria Quay, Edinburgh; Cumbria County Council Offices. The Courts, Carlisle; Carlisle City Council Offices, Civic Centre, Carlisle; The Post Office, 199 Central Avenue, Gretna; The Highways Agency, Road Programme Directorate, Administrative Services Division, Room 12/08, St. Christopher House, Southwark Street, London; The Highways Agency, Road Programme Directorate, Motorway Operations Division, 5 Broadway, Broad Street, Birmingham; Government Office North West, Sunley Tower, Piccadilly Plaza, Manchester and Government Office North East, Wellbar House, Newcastle Upon Tyne.

Any person may object to the making of this supplementary Order not later than 31st May 1996, or within 6 weeks from the date of first publication of this notice if that period expires later, by notice to the Secretary of State at the office of the Director of Roads, The Scottish Office Development Department, National Roads Directorate, Victoria Quay, Edinburgh EH6 6QQ, quoting reference RUP/135/53/1/50. #### PETROLEUM AND SUBMARINE PIPE-LINE ACT 1975

Notice of the issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Mobil North Sea Limited, whose address is Mobil Court, 3 Clements Inn, London WC2A 2EB, for the construction of a 136-5 millimetre production pipe-line, water injection pipe-line and gas lift pipe-line and also several 50-8 millimetre bulk chemical/gas lift pipe-lines and 12-7 millimetre chemical injection pipe-lines between Nevis South and the Beryl Riser Access Tower.

Except with the consent of the Secretary of State, the 136-5 millimetre pipe-lines shall only be used to convey crude oil, injection water and lift gas respectively and the bulk chemical/gas lift pipe-lines and chemical injection pipe-lines shall only be used to convey bulk chemicals and hydrocarbon gas and corrosion and scale inhibitors and methanol.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Mobil North Sea Limited has been appointed operator of the pipe-lines.
