

## KNOWSLEY METROPOLITAN BOROUGH COUNCIL

*The Council of the Borough of Knowsley (Greensbridge Lane and Netherley Road, Tarbock) (40 m.p.h. Speed Limit) Order 1996*

Notice is hereby given that on 18th April 1996, the Council of the Borough of Knowsley, made an Order under section 84(1) and (2) of the Road Traffic Regulation Act 1984.

The Order will come into effect on 3rd June 1996, the purpose of which will be to impose a speed limit of 40 m.p.h. on:

- (a) that length of Greensbridge Lane, Tarbock, commencing at its junction with Netherley Road, extending in a southerly direction to a point where the existing 30 m.p.h. restrictions begin 15 metres north of its junction with Lower Road, a distance of approximately 1,990 metres; and
- (b) that length of Netherley Road, Tarbock, commencing at a point approximately 250 metres south-east of its junction with Water Lane, extending in a north-westerly direction to a point approximately 200 metres north-west of its junction with Ox Lane, a distance of approximately 1,000 metres.

*The Council of the Borough of Knowsley (Valley Road, Kirkby) (Prohibition of U-Turns) Order 1996*

Notice is hereby given that on 18th April 1996, the Council of the Borough of Knowsley made the above-named Order under the Road Traffic Regulation Act 1984.

When this Order comes into effect on 3rd June 1996, no person(s) shall except upon the direction of a police constable in uniform, cause or permit any vehicle proceeding in either the north-westerly or the south-easterly carriageway, as the case may be, of Valley Road, Kirkby, to make a U-Turn through the gap in the central reservation at its junction of Whitefield Drive and Bewley Drive, so as to proceed in the opposite direction in either the north-westerly carriageway or the south-easterly carriageway, as the case may be.

*The Council of the Borough of Knowsley (Huyton Hey Road, Huyton) (Box Junction) Order 1996*

Notice is hereby given that on 18th April 1996, the Council of the Borough of Knowsley, in exercise of its powers, made an Order under section 1(1) and (2), 2(1) and (2) and 4 of the Road Traffic Regulation Act 1984.
