Notice is hereby given that the Leicester City Council as agents authorised by the Leicestershire County Council have made the following Order under sections I and 2 of the Road Traffic Regulation Act 1984, to come into operation on 8th April 1996.

The effect of the Order is to:

Prohibit a vehicle from waiting at any time, except for permitted loading for a period of 20 minutes in:

Southfields Drive South (south side), the south carriageway, between points 145 metres and 165 metres west of its eastern extremity (near Windley Road).

If you wish to question the validity of the Order or any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order you may, within 6 weeks from 8th April 1996, apply to the High Court for this purpose.

The Leicester Traffic Regulation (Amendment) (Belgrave Gate Area) Order 1996

Notice is hereby given that the Leicester City Council as agent authorised by Leicestershire County Council proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984. The effect of this Order will be to:

1. Prohibit a vehicle from waiting or loading at any time in:

Abbey Street (the south-west side), between points 43 metres and 50 metres south-east of its junction with Burleys Way.

Prohibit a vehicle from waiting at any time, except for permitted loading for a period of 20 minutes in:

Belgrave Gate

(a) the north-west side:

(i) between a point 39 metres north-east of its junction with Abbey Street and a point 5 metres north-east of its junction with Garden Street;

(ii) between a point 15 metres north-east of its junction with Garden Street and a point 3 metres north-east of its junction with Orchard Street;

(b) the south-east side:

(i) between points 5 metres north-east and 5 metres southwest of its junction with Wilton Street;

(ii) between a point 23 metres south-west of its junction with Wilton Street and a point 9 metres south-west of its junction with Jubille Road.

Garden Street (both sides), between a point 18 metres north-east of its junction with Abbey Street and its junction with Belgrave Gate.

New Purliament Street (both sides), between its junction with Belgrave Gate and a point 9 metres north-west thereof.

Orchard Street

the south-west side:

(i) between points 27 metres and 35 metres north-west of its juncion with Belgrave Gate;

(ii) between points 23 metres and 28 metres south-east of its junction with Royal East Street.

the north-east side, between its junction with Belgrave Gate and a point 9 metres north-west thereof.

3. Prohibit a vehicle from waiting at any time except for permitted loading for a period of 20 minutes between the hours of 9.30 a.m. to 4 p.m. and 6 p.m. to 7.30 a.m. Monday to Friday and all day Saturday and Sunday in:

Abbey Street (the north-east side), between points 9 metres and 25 metres south-east of its junction with Garden Street.

Belgrave Gate:

(a) the north-west side, between points 43 metres south-west and 14 metres north-east of its juncion with Abbey Street.

- (b) the south-east side, between a point 29 metres south-west of its junction with Jubilee Road and its junction with Charles Street. Gurden Street (both sides), between its junction with Abbey Street and a point 18 metres north-east thereof.
- Prohibit a vehicle from waiting between the hours of 9.30 a.m. and 4 p.m. Monday to Saturday, except for limited waiting for a period of 30 minutes in:

Belgrave Gate (the north-west side), between points 14 metres and 39 metres north-east of its junction with Abbey Street.

 Prohibit a vehicle from waiting between the hours of 9.30 a.m. and 4 p.m. Monday to Saturday, except for limited waiting for a period of 60 minutes in:

Belgrave Gate

(a) the north-west side:

(i) between points 5 metres and 15 metres north-east of its junction with Garden Street;

(ii) between a point 3 metres north-east of its junction with Garden Street and a point opposite the north-east side of its junction with Gower Street.

(b) the south-east side:

- (i) between a point 7 metres south-west of its junction with Gower Street and a point 5 metres north-east of its junction with Wilton Street;
- (ii) between points 5 metres and 23 metres south-west of its junction with Wilton Street;

(iii) between points 9 metres and 29 metres south-west of its junction with Jubilee Road.

Orchard Street (the south-west side), between points 20 metres and 24 metres north-west of its junction with Belgrave Gate.

6. Intrduce a "one-way" restriction in:

Gurden Street (the whole length), between its junction with Abbey Street and Belgrave Gate, from Abbey Street towards Belgrave Gate.
