

## LEICESTER CITY COUNCIL

*The Leicester Traffic Regulation (Amendment) (Grace Road) Order 1996*

Notice is hereby given that Leicester City Council as agent authorised by Leicestershire County Council proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984. The effect of the Order will be to:

Prohibit a vehicle from waiting at any time, except for permitted loading for a period of 20 minutes, in:

*Grace Road:*

- (a) the north side, between points 18 metres north-west and 18 metres south-east of its junction with Percy Road;
- (b) the south side, between a point 10 metres north-west of its junction with Percy Road and a point 33 metres north-west of its junction with Saffron Lane.

*Percy Road:*

- (a) the west side, between its junction with Grace Road and a point 5 metres south-west thereof;
- (b) the east side, between its junction with Grace Road and a point 18 metres south-west thereof.

A copy of the draft Order, a copy of the relevant map and a copy of the Council's statement of reasons for proposing to make the Order may be seen at the Legal Services Division, New Walk Centre, Welford Place, Leicester, at all reasonable hours.

## LEICESTERSHIRE COUNTY COUNCIL

*The Leicestershire County Council (Various Roads, Ashby to Boundary, Counties of Leicestershire and Derbyshire) (50 m.p.h. Speed Limit) Order 1996.*

Notice is hereby given that Leicestershire County Council, with the consent of Derbyshire County Council being the Highway Authority for lengths of roads in Derbyshire, has made an Order under section 84(1) and (2) of the Road Traffic Regulation Act 1984, the effect of which will be that no person shall drive any motor vehicle at a speed exceeding 50 m.p.h. on those lengths of roads specified in the Schedule to this notice.

The Order will come into force on 22nd April 1996.

*Roads in Leicestershire and Derbyshire*

*Ashby Road/Burton Road (A50)*, from a point some 480 metres north-west of Atkinson Road, some 20 metres north-west of the point where Right of Way No. 076 joins route the A50, in a north-westerly direction to a point 6 metres west of Heath Lane (Blackfordby Turn) Boundary, a distance of approximately 2 kilometres (1.2 miles).

*Ammwell Lane*, from its junction with Ashby Road/Burton Road (A50) in a north-easterly direction for a distance of 30 metres.

*Heath Lane* (Smisby turn), from its junction with Ashby Road/Burton Road (A50) in a northerly direction for a distance of 75 metres.

*The Leicestershire County Council (Nottingham Road (A50) (Part) Ashby de la Zouch) (Prohibition of U-turn) Order 1966*

Notice is hereby given that the Leicestershire County Council has made an Order under sections 1(1) and (2), 2(1) to (3) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit any vehicle proceeding in a north-easterly direction along Nottingham Road (A50) Ashby de la Zouch to make a u-turn from the north-east bound carriageway to the south-west bound carriageway of Nottingham Road (A50) adjoining its junction with Resolution Road.

The Order will come into force on 22nd April 1996.

## NORTH WEST LEICESTERSHIRE DISTRICT COUNCIL

*The District of North West Leicestershire (Meadow Lane, Coalville and North Street, Whitwick) (Prohibition of Waiting) Order 19 and (Vicarage Street, Whitwick) (Prohibition of Waiting and Revocation Order 19*

Notice is hereby given that the North West Leicestershire District Council (acting as agents for Leicestershire County Council) proposes to make Orders under sections 1(1) and (2), 2(1) to (3) of the Road Traffic Regulation Act 1984 and to revoke in part an Order in accordance with Part IV of Schedule 9 to that Act.

When these Orders come into effect:

- (1) You will not be allowed to leave your vehicle in the following lengths of road:

*No Waiting At Any Time*

*Meadow Lane*, Coalville, on its north-west side from a point outside the boundary of Nos. 87-89 to a point outside the boundary of Nos. 83-85 Meadow Lane.

*Vicarage Street*, Whitwick, on its south-east side from a point 12 metres from the end of the cul-de-sac adjoining route B587 in a north-easterly direction for a distance of 16 metres.

*North Street*, Whitwick, on its south-west side for a distance of 10 metres either side of the access to Nos. 101-119 North Street measured from the centre of the access road.

Exceptions will permit waiting for picking up and setting down passengers, loading and unloading of goods, disabled person's vehicles etc.

- (2) You will be able to leave your vehicle in the following length of road where previously a prohibition of waiting Order was in force.

*Unrestricted Waiting*

*Vicarage Street*, Whitwick, on its north-west side from a point 5 metres from its junction with Castle Street for a distance of 30 metres in a south-westerly direction.

Full details of these proposals are in draft Orders, plans and a statement of the Council's reasons for proposing to make the Orders. These may be examined at the Council Offices, Whitwick Road, Coalville, Leicestershire, between 9 a.m. to 5 p.m., Monday to Friday. (Ask for Lesley Birtwistle).

If you wish to object to the proposed Orders you should do so in writing, stating the grounds of your objections, to be received by the Chief Executive and Clerk, Council Offices, Coalville, Leicestershire LE67 3FJ.
