NEW ROADS AND STREET WORKS ACT 1991, SECTION 58

Notice of Substantial Road Works

Three months' advance notice is hereby given that Halton Borough Council, as agents for Cheshire County Council, who are the Highway Authority, intend to carry out substantial works for road purposes.

The works involve carriageway reconstruction and resurfacing.

The streets in which these works will take place are listed in the following Schedule, together with expected dates of commencement.

Subject to the exemptions in the Act and Regulations under it no street works may be executed for a period of 12 months from completion of the works described in the Schedule without the consent of the said Halton Borough Council, which shall not be unreasonably withheld.
