UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing body of St. John's College, Cambridge, on 7th March 1996, amending Statutes XLIX, LI, LIII and LVIII has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purpose of this Statute is to simplify the grievance procedure for academic staff, to allow surplus income of trust funds to be used in subsequent years, to amend the procedure for affixing the Common Seal, and to alter the wording of the Statutes in relation to the Education Reform Act 1988. UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing body of the University of Cambridge, on 1st April 1996, amending Statute K, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purpose of this Statute is to provide for the inclusion of St. Edmund's College among the Colleges of the University of Cambridge. (2 SI)

UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the University of Cambridge, on 11th March 1996, amending Statute D has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purpose of this Statute is to introduce a second office of Pro-Vice-Chancellor. (3 SI)
