Notice of the issue of a submarine pipe-line works authorisation

Except with the consent of the Secretary of State, the 406.4 mm and 273.1 mm pipe-lines shall only be used to convey crude oil.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Stopping-up of a Highway at Lower Withington, near Macclesfield

The Secretary of State for Transport hereby gives notice that on the application of Fairhurst Consulting Engineers on behalf of Hepworths Minerals and Chemicals and following the holding of a public local inquiry, he has made an Order under section 247 of the Town and Country Planning Act 1990 entitled "The Stopping-up of Highways (County of Cheshire) (No. 1) Order 1996", authorising the stopping-up of a length of Lapwing Lane (also known as Acre Nook Road) at Lower Withington near Chelford and requiring the improvement of highways.

If any person aggrieved by the Order desires to question its validity or the validity of any provision contained in it, on the ground that it is not within the powers conferred by the above Act or that any requirement of that Act or of any regulations made under it has not been complied with in relation to the Order, he or she may, within 6 weeks from 24th April 1996, apply to the High Court for the suspension or quashing of the Order or of any provision contained in it.
