*Lengths of roads at Brent Pelham subject to a 30 m.p.h. speed limit*

*B1038 Pumphill*, from a point 434 metres south-east of its junction with The Causeway north-westwards for a distance of 1,271 metres.

*Unnamed Road C10*, from its junction with Pumphill northwards for a distance of 987 metres.

*U1 Anstey Road*, from its junction with C10 north-westwards for a distance of 193 metres.

*U28 Violet Lane*, from its junction with B1038 Pumphill southwards for a distance of 260 metres.
