NOTICE OF SEIZURE

Pursuant to section 139(6) of the Customs and Excise Management Act 1979 ("the Act") and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts, certain goods, namely 10,348-8 litres of Clan Ardoch blended Scotch Whisky have been seized as liable to forfeiture by force of the following provisions namely:

Regulation 16 of the Excise Goods (Holding Movement Warehousing and REDS)

Regulations 1992 Section 49(1) of the Act

Section 124(1) of the Act.

If you claim that the said goods are not liable to forfeiture you must, within one month from the date of this notice of seizure, give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 to the Act.

If you are outside the United Kingdom and the Isle of Man you must also give the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and act on your behalf.

If you do not give notice of claim within the said period of one month or, if any requirement of the above-mentioned paragraph 4 is not complied with, the goods in question will be deemed to have been duly condemned as forfeited.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condemnation of the said goods.
