PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by BP Exploration Operating Company Limited, whose address is Britannic House, 1 Finsbury Circus, London EC2M 1BA, for the construction of 226-2mm (8.91 inch) and 183-6mm (7.23 inch) pipe-lines between subsea water injection manifold and Magnus South subsea water injection well and Magnus D6 subsea well.

Except with the consent of the Secretary of State, the 226-2mm pipe-line shall only be used to convey treated water and the 183-6mm shall only be used to convey treated water also.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

BP Exploration Operating Company Limited has also been appointed operator of the pipe-lines.
