

## ROAD TRAFFIC ACTS

## BERKSHIRE COUNTY COUNCIL

*Royal County of Berkshire (High Street (Ringside) Bracknell) (Traffic Regulation) (Prohibition and Restriction of Waiting and One Way Traffic) Order 1996.*

Notice is hereby given that the County Council of the Royal County of Berkshire proposed to make an Order under sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 the effect of which is to:

- (1) Create limited waiting for 30 minutes (Monday to Saturday 8 a.m. to 6 p.m.) on the south side of High Street from a point 40 metres west of the west side of its junction with The Ring westwards for a distance of 42 metres; and
- (2) provide 3 disabled persons parking bays on the south side of High Street from a point 20 metres west of the west side of its junction with The Ring westwards for a distance of 20 metres.

The remaining lengths of High Street on both sides will continue to have no waiting at any time and one way traffic flow along High Street from its junction with Market Street to The Ring.
