The Hampshire County Council Prohibition of Driving and Waiting Restrictions in Middle Road Area, Winchester

Notice is hereby given that Hampshire County Council proposes making two Road Traffic Regulation Orders as follows:

Effect of Orders: To prohibit the driving of all motor vehicles in the following roads at Winchester between the hours of 8 a.m. and 6 p.m., from Monday to Saturday (both days inclusive):

Middle Road, South View Access Road, South View, Step Terrace.

Exemptions will be included for loading/unloading, access to parking areas off the highway and for holders of Area J parking permits and/or their visitors. In addition waiting will be prohibited at any time on the following sides of Middle Road:

- (i) East side between a point 171.6 metres north of its junction with Step Terrace and a point 183.7 metres north of that junction.
- (ii) West side between a point 19.9 metres north of its junction with South View and a point 37.2 metres north of that junction.
