#### PUBLIC SCHOOLS ACT 1868

The Governing Body of Westminster School have made revised Statutes in the terms appended hereto and the same is hereby published in *The London Gazette* as required by the above-named Act.

Any persons or body corporate authorised by the said Act may within two months after the publication hereof petition Her Majesty in Council to withhold Her Approval from the whole or any part of the said Statutes.

#### WESTMINSTER SCHOOL

*A body of Statutes amending in divers particulars the Statutes of the School now in force and repealing certain parts thereof and consolidating the same with amendments thereof in one body of Statutes.*

Whereas Saint Peter's College Westminster, otherwise called Westminster School, is a School to which the Public Schools Act, 1868, and the Acts amending the same, apply.

And whereas under the powers of the said Acts divers Statutes for the School have from time to time been made and approved in the manner provided by the said Acts, and divers of the said Statutes in the manner provided by the said Acts, and divers of the said Statutes have from time to time been amended, repealed, or replaced, by later Statutes similarly made and approved with the result that the Statutes of the School now in force by virtue of the said Acts or otherwise consist of the following namely:

Statutes determining and establishing the Governing Body, approved by Order of Council on October 1869

Subsequently amended by:

- (a) Statute made on 16th December 1874, approved by Order in Council on 28th June 1875;
- (b) Statute made on 5th November 1879, approved by Order in Council on 26th February 1880;
- (c) Statute made on 27 May 1935, approved by Order in Council on 13th August 1935;
- (d) Statute made on 22nd May 1967, approved by Order in Council on 23rd August 1967;

Statute for regulating the Constitution and Government of the School, made by the Governing Body on 28th July 1871, approved by Order in Council on 3rd November 1871

And whereas it is expedient to amend in divers particulars the Statutes of the School now in force, and to repeal certain parts thereof, and consolidate the same, with the amendments thereof, in one Body of Statutes in manner hereinafter appearing:

Now We, the Governing Body of Westminster School, do hereby, in exercise of the powers of the Public Schools Act, 1868 and the acts amending the same, and of all other powers enabling us in that behalf, enact as follows:

#### General

1. In these Statutes the words in the first column of the table next shall bear the meanings (if not inconsistent with the subject or context) set opposite to them in the second column thereof:

The Statutes	These Statutes and the regulations of the Governing Body from time to time in force.
The Dean and Chapter	The body corporate known as the Dean and Chapter of the Collegiate Church of St. Peter, Westminster, otherwise known as Westminster Abbey.
