#### TRANSPORT AND WORKS ACT 1992

Leeds Supertram (Extension) Order

Notice is hereby given that application is being made by the West Yorkshire Passenger Transport Executive and Leeds City Council to the Secretary of State for Transport, Department of Transport, Great Minster House, 76 Marsham Street, London SW1P 4DR, for an Order under section 1 of the Transport and Works Act 1992 for purposes of which the following is a concise summary:

- 1. To authorise the construction, maintenance and operation of an extension to the light rail system authorised by the Leeds Supertram Act 1993, comprising street tramways and tramroads in the City of Leeds. The route commences at a park and ride site on the site of the University athletic grounds at Lawnswood then passes on street along Otley Road through Weetwood and Headingley, off street through Headingley Centre, on street along Headingley Lane and Woodhouse Lane, over the inner ring road motorway on a bridge to be constructed then back on street along the western side of Woodhouse Lane (to be widened) and along Cookridge Street where it links with Line 1 (authorised but not yet constructed). The route then passes eastwards on street along the Headrow and Eastgate, off street through the markets area and eastwards on street along York Street, Marsh Lane and Burmantofts Street, off street adjacent to Beckett Street, then on street along Harehills Road, Roundhay Road and Easterly Road, off street through Wykebeck, on street along North Parkway, Ring Road Seacroft (to be widened), off street on land adjacent to Hebdon Approach, on street along Baildon Drive and terminating at a proposed park and ride site at Grimes Dyke off York Road. In addition the route will run along Duncan Street, Call Lane and New York Street completing a city centre loop. The Order also authorises associated highway and ancillary works along or adjacent to the route together with works affecting Cliff Road, Delph Lane and Blenheim Walk.
- 2. To provide for the compulsory acquisition of land and rights in land for the intended works and related purposes including working sites, landscaping and exchange land; extinction of rights of way over land to be acquired; appropriation of the subsoil of or airspace over streets; and temporary possession of land for construction, maintenance and related purposes.
- 3. To provide for the alteration of the layout of streets; the placing of equipment and apparatus in streets; the permanent stopping up of (or of vehicular rights in) specified streets and the temporary stopping up of streets for the purposes of construction of the works; entering into agreements with the street authority with respect to the construction of or interference with streets; specified level crossings carrying the authorised tramroads over highways; discharge of water in connection with the construction or maintenance of the authorised works; carrying out of safeguarding works to buildings; and the entering on land for the purpose of surveying and investigating land.
- 4. To apply provisions of the Leeds Supertram Act 1993 including provisions for the power to cut and lop overhanging trees; the attachment of brackets to buildings; the removal of human remains; the removal of obstructions to the trams using the tramways system; regulating the use of electricity; the giving of notice to the police and to the fire authority; penalty fares; the operation of the tramway system; the making of byelaws regulating the use of the proposed system; the extension to supertrams of regulations relating to buses; the prevention of trespass; contracts with police; and the disposal or franchising of the system.
- 5. To apply provisions of the New Roads and Streets Works Act 1991 and incorporate provisions of the Railways Clauses Acts and modify and disapply railway enactments.

And notice is further given that-

(a) In respect of the development described above application is being made to the Secretary of State for deemed planning permission subject to the reservation of certain specified matters for subsequent approval by the local planning authority.

(b) Waiver directions have been given by the Secretary of State in respect of certain provisions of the Transport and Works (Applications and Objections Procedure) Rules 1992 and form one of the documents submitted with the application. ## WATER RESOURCES ACT

### **ENVIRONMENT AGENCY**

Notice of application for a licence to abstract water

Take notice that H. Sherwood, of 'Westlands', Sandhill Farm, Car Lane, Newport Brough, East Yorkshire, is applying to the Environment Agency for a licence to abstract water from the River Foulness, between National Grid Reference SE 8299 3239 and SE 8471 3254 and the Market Weighton canal, between SE 8491 3207 and SE 8493 3202, in the parishes of Home-on-Spalding-Moor and Newport in the East Riding of Yorkshire.

The proposal is to abstract water at the following rates: (1) 23 cubic metres per hour, 411 cubic metres per day, 59,091 cubic metres between April and October each year and (2) 114 cubic metres per hour, 1,140 cubic metres per day, 13,637 cubic metres between December and March each year. The water will be used for (1) spray irrigation for horticulture and (2) winter storage for subsequent spray irrigation. This replaces an existing licence.

A copy of the application and any map, plans and other documents submitted with it may be inspected, free of charge, at all reasonable hours at the above address between 4th July and 4th August 1996.
