Effect of Order: To impose 30 and 40 m.p.h. speed limits in Dunbridge as set out below:

Lengths of road at Dunbridge in the Borough of Test Valley 40 m.p.h. Speed Limit:

- (i) B3084 between a point 710 metres north of its junction with Bengers Lane and a point 1,420 metres south of that point.
- (ii) B3084 between a point 340 metres south of its junction with Mill Rise and a point 630 metres south of that point.

30 m.p.h. Speed Limit:

- (i) B3084 between a point 340 metres south of its junction with Hatt Lane and a point 475 metres south-east of that point;
