#### GLOUCESTERSHIRE COUNTY COUNCIL

*Gloucestershire County Council (A38 Gossington Bridge)  
(Prohibition of Entry and U-Turn) Order 1996*

Notice is hereby given that the Gloucestershire County Council intend to make an Order under the Road Traffic Regulation Act 1984, the effect of which will be to:

- (1) Prohibit any person from causing or permitting any vehicle to make a "U" turn so as to proceed in the opposite direction in that length of road (northbound carriageway only) known as Roman Road (A38), in the parish of Slimbridge, in the district of Stroud, in the county of Gloucestershire, which extends from (but excluding) the roundabout at the junction between Roman Road (A38) and St. John's Road (3/227) for a distance of approximately 1,475 metres in a south-westerly direction; and
- (2) Prohibit any person from causing or permitting any vehicle to be driven in an easterly direction through the central reservation gap, past the point 1 metre from the south-eastern kerbline of the northbound carriageway of Roman Road (A38), in the parish of Slimbridge, in the district of Stroud, in the county of Gloucestershire, at a location 236 metres south-west of the junction with the centre line of Tyndale Road (3/228) at Gossington Bridge.

*Gloucestershire County Council (Tibbiwell Painswick) (Prohibition of Waiting) Order 1996*

*Hartlepool Borough Council (Fens School) (Restriction of Waiting, Loading and Unloading) Order 1996*
