The Secretary of State for Transport hereby gives notice that he has made the following Scheme and orders:

The AI Motorway (North of Leeming to Scotch Corner Section and Connecting Roads) Scheme 1996

A Scheme under sections 16, 17 and 19 of the Highways Act 1980 authorising him to provide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1980 a special road ("the motorway") about 17.25 kilometres in length from a point on the A1 Trunk Road 250 metres south of the entrance to Holtby Hall going in a northerly direction to connect with the existing A1 Motorway at a point 348 metres south of the centre of Barton Grade Separated Junction and special roads to connect the above mentioned special road as follows:

- (i) four routes to connect the motorway with the link road which connects the A6136 Leeming Lane to the A6136 Catterick Lane;
- (ii) four routes to connect the motorway with the A66 Scotch Corner Grade Separated Junction; and
- (iii) two routes to connect the motorway with the B6275.

The A1 Trunk Road (North of Leeming to Scotch Corner Section Side Roads) Order 1996

An Order under sections 12, 14 and 125 of the Highways Act 1980 authorising him to-

- (a) carry out improvement of highways,
- (b) stop up highways,
- (c) construct new highways (three of which are temporary),
- (d) stop up private means of access to premises and
- (e) provide new means of access to premises,

in the districts of Hambleton and Richmondshire all in the county of North Yorkshire and providing for the transfer of each new highway, other than a temporary highway, to North Yorkshire County Council from the date on which he notifies them that it has been completed and is open for traffic.

The A1 Trunk Road (Lengths of A1 Carriageway between Catterick and Barton) (Detrunking) Order 1996

An Order under sections 10 and 12 of the Highways Act 1980 providing that lengths of the A1 Trunk road and connecting slip roads to be superseded by the motorway and connecting roads shall cease to be a trunk road from the date on which the Secretary of State notifies North Yorkshire Council that the motorway and connecting roads are open for use as special roads.

The A1 Motorway (North of Leeming to Scotch Corner Section and Connecting Roads Appropriation) Order 1996

An Order under section 18 of the Highways Act 1980, which provides that each length of trunk road described in the Schedule to this Order and which is comprised in the route of a special road which the Secretary of State is authorised by the Al Motorway (North of Leeming to Scotch Corner Section and Connecting Roads) Scheme 1996 to provide, shall be appropriated as part of that special road from the date on which that road is first open for use as a special road.
