The Croydon (Purley Oaks/Sanderstead Area) (Parking Places) (No. 1) Traffic Order 1996

The Croydon (Waiting and Loading Restriction) (Amendment No. 8) Traffic Order 1996

Notice is hereby given that the Council of the London Borough of Croydon on 16th July 1996, made the above-mentioned Orders under the powers of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, the Road Traffic Regulation (Parking) Act 1986 and the Road Traffic Act 1991.

The general effect of the Croydon (Purley Oaks/Sanderstead Area) (Parking Places) (No. 1) Order 1996 would be:

- (a) to designate parking places in Broomhall Road, Glossop Road, Kendall Avenue and Parrs Close at which charges may be made by the Council for the leaving of vehicles authorised by the Order;
- (b) to specify that passenger vehicles (with 12 seats or less), goods carrying vehicles, motor cycles and invalid carriages might be left in the parking places provided;
- (c) to provide that the parking places will be in operation between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays (inclusive) except Christmas Day, Good Friday and Bank Holidays and will be controlled by means of "pay and display" parking with payment to a ticket parking meter or by the display of a valid residents or visitors parking permit;

(d) to provide that at the parking places situated on the highways specified, the charge for leaving a vehicle will vary from 10p for 30 minutes up to 80p (maximum) for 4 hours (maximum);

- (e) to provide that a vehicle displaying a valid parking permit, available from the London Borough of Croydon, may park for a period of 8 hours (maximum). Parking permits may be obtained at a cost of:

 - (i) £25 per annum in respect of resident permits; or(ii) £2.50 per book of 5 resident visitors permits, each permit remaining valid for use for a period of a year from the date of its issue. (Each household will be limited to a maximum of 30 visitors permits per year.)

The general effect of the Croydon (Waiting and Loading Restriction) (Amendment No. 8) Traffic Order 1996, in association with the introduction of controlled parking, will be to introduce restrictions on waiting by vehicles:

- (a) between the hours of 8 a.m. and 6.30 p.m. on Mondays to Fridays inclusive in lengths of Edgar Road and Kendall Avenue;
- (b) between the hours of 9 a.m. and 5 p.m. on Mondays to Saturdays inclusive in lengths of Broomhall Road, Florence Road, Glossop Road, Kendall Avenue and Parrs Close

Copies of the Orders which will come into operation on 22nd July 1996, can be inspected during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Orders were made, at the Enquiry Counter, "One Stop" Facility.
