

- (c) introduce Residents' Visitor Parking Cards which will be made available to households in the Enfield Town area which will allow visitors to park their vehicles in a resident's parking place, provided they display a valid parking card;
- (d) introduce business parking permits in all of the Enfield Parking Zones which may be transferred between vehicles (though not between Zones).

Other minor and consequential changes are also included in the proposed schemes.

1. Notice is hereby given that the Council of the London Borough of Enfield, on 29th July 1996 made:

- (a) the Enfield (Resident's Parking Places) (Bush Hill Park) (Special Parking Area) (Amendment No. 2) Order 1996;
- (b) the Enfield (Resident's Parking Places) (Grange Park) (Special Parking Area) (Amendment No. 2) Order 1996;
- (c) the Enfield (Resident's Parking Places) (Oakwood) (Special Parking Area) (Amendment No. 2) Order 1996;
- (d) the Enfield (Resident's Parking Places) (Enfield Town) (Special Parking Area) (Amendment No. 3) Order 1996;
- (e) the Enfield (Free Parking Places) (Special Parking Area) (No. 2) Order 1996;
- (f) the Enfield (Business Parking Places) (Bush Hill Park) (Special Parking Area) (Amendment No. 1) Order 1996;
- (g) the Enfield (Business Parking Places) (Grange Park) (Special Parking Area) (Amendment No. 1) Order 1996;
- (h) the Enfield (Business Parking Places) (Oakwood) (Special Parking Area) (Amendment No. 1) Order 1996;
- (i) the Enfield (Business Parking Places) (Enfield Town) (Special Parking Area) (Amendment No. 1) Order 1996;

under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, and the Road Traffic Act 1991.

2. The general effect of the Residents' Parking Places (Bush Hill Park) Order will be to amend the Enfield (Residents' Parking Places) (Bush Hill Park) (Special Parking Area) (No. 1) Order 1994, so that:

- (a) special permits and protective covers will be issued by the Borough Council on application being made by a provider of private health care, provided that the applicant is required to visit a person residing in a street or length of street within the Bush Hill Park Controlled Parking Zone and who is the owner of a passenger vehicle (12 seats or less), a goods carrying vehicle not more than 2.28 metres in height, a motor cycle or an invalid carriage;

(NOTE: the special permits are valid for all Controlled Parking Zones within the London Borough of Enfield);

- (b) carer's permits and protective covers will be issued by the Borough Council on application being made by a person who provides care to an elderly or infirm person residing in a street or length of street within the Bush Hill Park Controlled Parking Zone on a regular and frequent basis and who is the owner of a vehicle of a class referred to in sub-paragraph (a) above;
- (c) the charge for the issue of a special permit or a carers' permit, which will be valid for a period of twelve months running from the beginning of the month in which it first becomes valid, shall be £20.

3. The general effect of the Residents' Parking Places (Grange Park) Order will be to amend the Enfield (Residents' Parking Places) (Grange Park) (Special Parking Area) (No. 1) Order 1994, so that similar provisions are made for special permits and carers' permits in the Grange Park Controlled Parking Zone as described in paragraph 2 above.

4. The general effect of the Residents' Parking Places (Oakwood) Order will be to amend the Enfield (Residents' Parking Places) (Oakwood) (Special Parking Area) (No. 1) Order 1994, so that similar provisions are made for special permits and carers' permits in the Oakwood Controlled Parking Zone as described in paragraph 2 above.

5. The general effect of the Residents' Parking Places (Enfield Town) Order will be to:

- (a) designate residents' parking places in Beresford Gardens, Chase Side, Fir Tree Walk, Fyfield Road, Gentleman's Row, Lincoln Road, Little Park Gardens, Queens Road, Raleigh Road and the service road fronting Nos. 43 to 63 Baker Street at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;
- (b) provide that the parking places will operate between 8 a.m. and 6.30 p.m., on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);

- (c) provide that residents' permits and protective covers will be issued by the Borough Council on application being made by any person residing in the streets or lengths of streets within the Enfield Town Controlled Parking Zone and who is the owner of a vehicle of the class referred to in paragraph 2(a) above;

- (d) provide that community health staff permits and protective covers will be issued by the Borough Council on application being made by the Enfield Community Care NHS Trust (maximum sixty-nine permits), the Chase Farm Hospital NHS Trust (maximum twenty-nine permits) or the New River Health Authority (maximum two permits) on behalf of an employee, provided that the employee is required to visit a person residing in a street or length of street referred to in sub-paragraph (c) above and who is the owner of a vehicle of a class referred to in paragraph 2(a) above;

(NOTE: the community health staff permits are valid for all Controlled Parking Zones within the London Borough of Enfield);

- (e) provide that social services staff permits and protective covers will be issued by the Borough Council on application being made by the Directorate of Social Services of the London Borough of Enfield (maximum one hundred permits) on behalf of an employee, provided that the employee is required to visit a person residing in a street or length of street referred to in sub-paragraph (c) and who is the owner of a vehicle of a class referred to in paragraph 2(a) above;

(NOTE: the social services staff permits are valid for all Controlled Parking Zones within the London Borough of Enfield);

- (f) provide that special permits and protective covers will be issued by the Borough Council on application being made by a provider of private health care, provided that the applicant is required to visit a person residing in a street or length of street referred to in sub-paragraph (c) and who is the owner of a vehicle of a class referred to in paragraph 2(a) above;

(NOTE: the special permits are valid for all Controlled Parking Zones within the London Borough of Enfield);

- (g) provide that carers' permits and protective covers will be issued by the Borough Council on application being made by a person who provides care to an elderly or infirm person residing in a street or length of street referred to in sub-paragraph (c) on a regular and frequent basis and who is the owner of a vehicle of a class referred to in paragraph 2(a) above;

- (h) provide that residents' visitor parking cards will be issued by the Borough Council on application being made by any person residing in the streets or lengths of streets referred to in sub-paragraph (c) above which may be used by any vehicle of a class referred to in paragraph 2(a) above:

provided that a maximum of fifty parking cards per year will be available to a household;

- (i) provide that the charge for the issue of a residents' permit, a special permit or a carers' permit, which will be valid for a period of twelve months running from the beginning of the month in which it first becomes valid, shall be £20;

- (j) provide that the charge for the issue of a community health staff permit or a social services staff permit, which will be valid for a period of twelve months running from the beginning of the month in which it first becomes valid, shall be £5;

- (k) provide that the charge for the issue of residents' visitor parking cards which, upon validation, will be valid for either a single morning period (8 a.m. to 2 p.m., on Mondays to Saturdays inclusive), or a single afternoon period (12 noon to 6.30 p.m., on Mondays to Saturdays inclusive), will be 50 pence each. These vouchers will be available in booklets comprising ten vouchers each. Up to a maximum of two validated vouchers may be displayed at any one time, which will allow parking all day in the parking space;

- (l) provide that certain vehicles may wait, free of charge, in certain circumstances, e.g. to allow persons to board or alight (maximum two minutes), to load or unload (maximum twenty minutes) and vehicles left by specified disabled persons (no time limit).

6. The general effect of the Free Parking Places Order will be to revoke the designation by the Enfield (Free Parking Places) (Special Parking Area) (No.1) Order 1994, of the free parking places numbered 55, 157 to 165 inclusive, 167 and 168 therein situated in Beresford Gardens, Chase Side, Enfield, Fir Tree Walk, Fyfield Road, Gentleman's Row, Lincoln Road, Little Park Gardens, Queens Road, Raleigh Road, Sydney Road and the service road fronting nos. 43 to 63 Baker Street.
