(c) to designate free parking places for goods vehicles only for the purpose of loading or unloading between the hours of 7 a.m. and 7 p.m. Monday to Saturday in High Street, Thornton Heath and Grange Park Road and to restict waiting thereon to a maximum periord of 30 minutes; and

(d) to redesignate bus stop clearways in High Street, Thornton Heath so that waiting by vehicles other than buses, taxis and cycles will be prohibited in the clearways at any time throughout the week, which areas will be marked on the carriageway by a yellow "Bus Stop" marking and by a double yellow line within that marking.
