

## DEVON COUNTY COUNCIL

*The County of Devon (Monksmead, Tavistock)  
(Prohibition of Waiting) Order*

Notice is hereby given that, on 21st August 1996, Devon County Council made the above Order under the provisions of the Road Traffic Regulation Act 1984, as published in *The London Gazette* No. 54345 dated 14th March 1996 (Ref. No. 505) to come into force on 9th September 1996. The effect of the Order is to prohibit waiting at any time in the following lengths of road at Tavistock:

*Callington Road*, both sides, from its junction with Monksmead eastwards and westwards for a distance of 50 metres.

*Monksmead*, both sides, from its junction with Callington Road southwards to a point 15 metres south-east of its junction with the south-western arm of Monksmead (leading to Deacons Green).

*Monksmead*, (south-west arm leading to Deacons Green), both sides, from its junction with Monksmead (south-eastern arm) south-westwards for a distance of 20 metres.

The Order contains the usual exemptions relating to disabled persons' vehicles, the maintenance of the road and telecommunications apparatus, and the supply of gas, water and electricity.

Full details are contained in the Order which, together with a plan, may be inspected during usual office hours at the offices of West Devon Borough Council, Kilworthy Park, Drake Road, Tavistock, or at Tavistock Library, Market Road, Tavistock (not Wednesday afternoon).

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks of the date on which the Order was made, apply to the High Court for this purpose.

*The Devon County Council (Elm Grove Road, Dawlish) (School  
Entrance Clearway) Order*

Notice is hereby given that Devon County Council propose to make the above Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit stopping in the following lengths of Elm Grove Road, Dawlish, adjacent to the entrance to Gatehouse County Primary School, which will be shown by zig zag road markings:

Elm Grove Road:

- north-east side, for 25.5 metres outside the school entrance;
- north-east side, from a point 15.5 metres north-west of the "No Entry" road markings south-eastwards for 33 metres; and
- south-west side, from its junction with Goodridge Close, south-eastwards for a distance of 25.2 metres.

Full details are contained in the Order, which together with a plan showing the affected lengths of roads and a statement of the Council's reasons for proposing to make the Order, may be examined during usual office hours at the offices of Teignbridge District Council, Forde House, Newton Abbot; the Cash Collection Office, Manor House, Dawlish; and at the Local Service Office, Newton Abbot; Devon County Council, Rydon Depot, Rydon Lane, Kingsteignton.

## ROAD TRAFFIC REGULATION ACT 1984

*Derbyshire County Council (The Castleway, Willington) (Speed  
Limit) Order 1996*

Notice is hereby given that Derbyshire Council Council propose to make an Order under section 84(1) of the Road Traffic Regulation Act 1984, imposing the following speed restrictions:

*30 m.p.h. Speed Limit*

*A5132 The Castleway*, from its junction with B5008 Repton Road in a westerly direction for a total distance of approximately 360 metres.

*The Castleway* (cul-de-sac fronting properties Nos. 200 to 218), from its junction with the A5132 The Castleway for its entire length.

*40 m.p.h. Speed Limit*

*A5132 The Castleway/Carriers Road*, from a point approximately 360 metres west of its junction with B5008 Repton Road to a point approximately 60 metres east of the centre-line of the A38 Burton Road overbridge.

*A5132 The Castleway* (A38 Eastern Slip Road), from a point 35 metres east of its junction with A38 Burton Road to its junction with A5132 Carriers Road.

The Order will supersede the existing 30 m.p.h. limit on The Castleway which exists by virtue of street lighting.

The draft Order, a map and a copy of the authority's statement of reasons for proposing the Order, may be examined in Room 109, County Hall, Matlock, Monday to Friday, between 9 a.m. and 5 p.m. and at Willington Post Office, 1 Castleway Lane, Willington.

*The Doncaster Borough Council (40 m.p.h. Speed Limit) (No. 3)  
Order 1996*

Notice is hereby given that on 19th August 1996, the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.
