

## DONCASTER BOROUGH COUNCIL

*The South Yorkshire County Council (Various Roads Armthorpe and Edenthorpe) (Traffic Regulation Consolidation) Order 1980 (Amendment No. 14) Order 1996.*

Notice is hereby given that on 20th August 1996, the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 2nd October 1996 will be to prohibit the waiting by vehicles at any time on both sides of that length of Beech Road at Armthorpe which extends from a point 15 metres north-east of its junction with Church Street for a distance of 37 metres in a north-easterly direction.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the Order and a map showing the restricted road may be examined at the offices of (i) the Borough Engineer, Scarborough House, Chequer Road, Doncaster, between the hours of 8.45 a.m. and 4.45 p.m., Monday to Friday, and (ii) Armthorpe Library, Church Street, Armthorpe, Doncaster, during normal opening hours.

If you wish to question the validity of the Order, or of any of the provisions contained therein, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 29th August 1996, apply to the High Court for this purpose.

## DORSET COUNTY COUNCIL

*The County of Dorset (Ferry Road and Heath Green Road, Studland) (Waiting Restrictions) Order 1996*

Notice is hereby given that Dorset County Council have made an Order under sections 1(1) and (2), 2(1) to (3) 4(2) and 124(1)(d) of the Road Traffic Regulation Act 1984.

When the Order comes into operation on the 30th August 1996 the effect will be to:

- (i) revoke 'The County of Dorset (Various Roads, Studland) (Prohibition and Restriction of Waiting) Order 1992 in so far as it relates to that length of Heath Green Road referred to in this Order.
- (ii) prohibit waiting between the hours of 10 a.m. and 7 p.m. from 15th March to 30th September inclusive on Ferry Road on its eastern side between points 176 and 250 metres south of Hardy's Road.
- (iii) limit waiting to 30 minutes (return prohibited within one hour) between the hours of 10 a.m. and 7 p.m. from 15th March to 30th September inclusive on Heath Green Road on its northern side between points 10 and 30 metres west of its junction with Ferry Road.

Exemptions will permit waiting for picking up or setting down passengers, loading or unloading goods, public service vehicles (whilst operating as a local service) at bus stops, disabled persons vehicles bearing the relevant orange badge, post office vehicles delivering and collecting mail, emergency service vehicles and vehicles in connection with any building or demolition operation, the maintenance of the road, the supply of gas, water or electricity and works to any telegraphic line.

A copy of the Order which together with a plan showing the lengths of road affected may be inspected from Monday to Friday during normal office hours at the Planning Department, Purbeck District Council, Westport House, Worgret Road, Wareham, Dorset and Transportation and Engineering Department, Dorset County Council, County Hall, Dorchester, Dorset.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made

under it has not been complied with in relation to the Order, you may, within 6 weeks, from the date of this notice apply to the High Court for this purpose.

## DORSET COUNTY COUNCIL

*The County of Dorset (Church Road, Ferndown) (Weight Restriction) Order 1996*

Notice is hereby given that Dorset County Council have made an Order under sections 1(1) and (2), 2(4) and 3(2) of the Road Traffic Regulation Act 1984, when the Order comes into operation on the 30th August 1996, the effect will be to prohibit heavy commercial vehicles over 7.5 tonnes maximum gross weight, except for loading purposes, from proceeding along Church Road, Ferndown for its entire length, between the C50 Wimborne Road and the A348 Ringwood Road, to also include that section of Westwood Avenue eastwards between its junctions with Church Road and Mayfield Way and Albert Road eastwards between its junctions with Church Road and Library Road.

An alternative route is provided by way of Wimborne Road, Victoria Road and Ringwood Road.

Exemptions will permit vehicles to proceed on that length of road referred to for the purposes of loading or unloading goods, post office vehicles delivering and collecting mail, emergency service vehicles, vehicles in connection with any building or demolition operation, the maintenance of the road, the collection of household refuse, the supply of gas, water or electricity, works to any telegraphic line, agricultural purposes and vehicles with a need to be garaged, serviced or repaired on any premises situated on or adjacent to that length of road referred to in this Order.

A copy of the Order which together with a plan showing the lengths of road affected may be inspected from Monday to Friday during normal office hours at the Planning Department, East Dorset District Council, Council Offices, Furzehill, Wimborne, Dorset and Transportation and Engineering Department, Dorset County Council, County Hall, Dorchester, Dorset.

## ESSEX COUNTY COUNCIL

*The Essex County Council (Civic Amenity Site Access Road/Park Drive, Maldon) (Prohibition of Right Hand Turn) Order 1996*

Notice is hereby given that, on 28th August 1996, the Essex County Council made the above Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit any vehicle proceeding in the Civic Amenity Site Access Road at Maldon in the district of Maldon to make a right-hand turn into Park Drive.

This Order brings into permanent effect the experimental prohibition of right-hand turns introduced in March 1995.

The Order will come into operation on 9th September 1996.
