## ROAD TRAFFIC REGULATION ACT 1984

*The Northamptonshire County Council (Various Roads, Rothwell) (Prohibition of Commercial Vehicles of Over 7.5 Tonnes Gross Weight) Order 1996.*

Notice is hereby given that the Northamptonshire County Council have made an Order under sections 1(1) and (2), 2(4) and 3(2) and Schedule 9 to the Road Traffic Regulation Act 1984. The general effect of the Order is to prohibit heavy commercial vehicles over 7.5 tonnes gross weight in those lengths of various roads in Rothwell as specified in the Schedule below.

A copy of the Order together with a plan showing the exact lengths of road to which it relates may be inspected at the Library, Market Hill, Rothwell, during normal opening hours, or at the offices of The Head of Legal Services, County Hall, Northampton NN1 1DN, between the hours of 9 a.m. and 12 noon and 2 p.m. and 4 p.m. on Mondays to Fridays inclusive.

If any person wishes to question the validity of the Order, or of any provision contained therein, on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or of any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order, you may within 6 weeks of the date of this notice, make application to the High Court.

The Order will become effective on 2nd September 1996.
