#### BUCKINGHAMSHIRE COUNTY COUNCIL

Buckinghamshire County Council (Pedestrian Zone, Aylesbury Centre) (Phase 2) Order 199

Notice is hereby given that Buckinghamshire County Council propose to make an Order under the Road Traffic Regulation Act 1984. Subject to certain exceptions, the general effect of the Order, if implemented, will be:

- to prohibit any vehicle from entering or proceeding at any time, on any day, in Kings Head Passage;
- to prohibit any motor vehicle from entering or proceeding on any day, between the hours of 8 a.m. and 6.30 p.m., in George Street, for a distance of 30 metres, north-westwards from its junction with Temple Street;

- 4. to prohibit any vehicle from entering or proceeding between the hours of 8 a.m. and 6.30 p.m., on any day, in the following roads or lengths of road: Pebble Lane; George Street, for a distance of 60 metres, south-westwards from its junction with Kingsbury; the north-western and the north-eastern carriageways of Market Square; Market Street; High Street, from its junction with Market Square, to a point level with the party wall between 20-22 and 24 High Street;
- 5. to prohibit any vehicle from entering or proceeding on any day, between 6.30 p.m. and 8 a.m., in the following roads or lengths of road: High Street, from its junction with Market Square, to a point level with the party wall between 20-22 and 24 High Street; the north-western carriageway of Market Square, from its junction with Kingsbury, to a point level with the party wall between 3 and 5 Market Square;
- to prohibit any motor vehicle from entering or proceeding at any time, on any day, in the western carriageway of Market Square;
- 7. to prohibit the waiting of any vehicle, at any time, on any day, with the exception that a vehicle may wait for the purposes of loading and/or unloading, between the hours of 9.30 a.m. to 4.30 p.m., and/or between 5.30 p.m. to 8 a.m., in both carriageways of Cambridge Street, from its junction with New Street to its junction with Buckingham Street;
- 8. to prohibit the waiting of any vehicle, at any time, on any day, with the exception that a vehicle may wait for the purposes of loading and/or unloading, between the hours of 4 p.m. to 10 a.m., in the following roads or lengths of road: the south-eastern carriageway of George Street; the north-western carriageway of George Street; the north-western carriageway of 7 metres, and from a point 31 metres from its junction with Kingsbury, to its junction with Temple Street; the northern carriageway of High Street, from its junction with Market Square, to a point level with the party wall between Marks and Spencer and W. H. Smith, and from a point level with, and 18 metres east of, the party wall between Marks and Spencer and W. H. Smith, to its junction with Brittannia Street; the southern carriageway of High Street, from its junction with Market Square, to its junction with Brittannia Street;
- 9. to vary existing Traffic Orders, so as to restrict the waiting of any vehicle to a period of one hour, with no return within one hour, from Monday to Saturday, between the hours of 8 a.m. and 5.30 p.m., in the following roads or length of road: lower High Street; the south-west carriageway of High Street, from a point 82 metres north-west of the centre line of Exchange Street, extending north-westwards, to a point 24 metres south-east of a point in line with the party wall of 32-32A High Street;
- 10. to vary existing Traffic Orders, so as to prohibit the waiting of any vehicle, at any time, on any day, with the exception that a vehicle may wait for the purposes of loading and/or unloading in the following roads or length of road; High Street, the southwest carriageway, from a point in line with the centre line of Brittannia Street, to a point in line with the party wall between 32 and 32A High Street; the south-eastern carriageway of Brittannia Street; the north-western carriageway of Brittannia Street, from its junction with High Street, to a point in line with the rear boundary wall of 39-41 High Street, and from a point 80 metres north-east of the north-east channel of High Street, to its junction with Anchor Lane;
- 11. to provide designated parking places for disabled persons in the following lengths of road: on the south-western side of lower High Street (four spaces); on the north-eastern side of upper High Street (three spaces); on the north-western side of Brittannia Street (seven spaces); on the north-western side of George Street (four spaces); on the south-eastern side of Cambridge Place (three spaces); note however, that a zone permit will be needed to permit disabled parking in the spaces in Upper High Street and George Street, which lie within the prohibited area. Such permits are to be issued at the discretion of the Council;

12. to facilitate one way traffic in the following lengths of road: Cambridge Street, from its junction with Buckingham Street, to a point level with the party wall between 33 and 25 Cambridge Street, north-eastwards; George Street, from its junction with Temple Square and Temple Street, a distance of 30 metres north-eastwards.


