#### PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

##### *Notice of the issue of a submarine pipe-line works authorisation*

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Wintershall (UK) Limited, whose address is the Old Town Hall, Wimbledon Broadway, London SW19 8YA, for the construction of a 219·10 mm. (8 inch) pipe-line and an umbilical consisting of three hydraulic flowlines between Windermere Platform and ST-1 Platform.

Except with the consent of the Secretary of State, the 219·10 mm. pipe-line shall only be used to convey natural gas and the umbilical shall only be used to convey methanol and corrosion inhibitors.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Lasmo Nederland B.V. has been appointed operator of the pipe-lines.
