Notice is hereby given that the Secretary of State for the Home Department has made an Order under section 4(2) of the Coroners Act 1988 for the revocation of the existing divisions of the County of Cornwall so as to form two Coroners' Districts in the County instead of three districts.

This Order amalgamates the two coroners' districts unaffected by the Cornwall (Coroners' Districts) (Amendment) Order 1991 to create a single new coroner's district for the districts of Carrick, Kerrier and Penwith, named the West Cornwall coroner's district. The new coroner's district created by the 1991 Order is renamed the East Cornwall coroner's district. The County of Cornwall is accordingly now divided between the West Cornwall coroner's district and the renamed East Cornwall coroner's district.

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

The A406 London North Circular Trunk Road (Angel Road, Enfield) (Temporary Prohibition of Traffic) Order 1996

The Secretary of State for Transport hereby gives notice that, to enable the erection of sign gantries, he has made an Order, the effect of which is to prohibit any vehicle without authorisation to enter or proceed in the Angel Road between Montagu Road and Fore Street.

Traffic will be directed as follows. Westbound traffic will turn right into Meridian Way (A1055), turn left at the roundabout into Lea Valley Road/Nags Head Road (A110) then left into Ponders End High Street, continuing along Hertford Street and Fore Street (A1010) until rejoining the North Circular Road A406. Eastbound traffic will turn left into Fore Street (A1010), continuing along Hertford Street and Ponders End High Street, turn right into Nag's Head Road/Lea Valley Road (A110) and then right at the roundabout into Meridian Way (A1055), until rejoining the North Circular Road (A406).

The Order came into force on Sunday, 6th October and the prohibition will have effect, when signs are displayed, for a maximum duration of 18 months from that date.
