THE CHEMICAL WEAPONS (NOTIFICATION)
REGULATIONS 1996

(As amended by the Chemical Weapons (Notification) (Amendment) Regulations 1996

The United Kingdom is required to make declarations, in relation to certain chemicals and chemical production facilities, to the Organisation for the Prohibition of Chemical Weapons (OPCW).

To enable the United Kingdom to meet fully its obligations to submit accurate information to the OPCW, the Secretary of State has made the above Regulations. These require that those persons, companies and organisations specified in the Regulations provide the Secretary of State, on or before 15th January each year with full details of their name, their address (or in the case of a company the address of its principal or registered office) and the address of each plant site he operates.

The above notification details must be in writing and be sent or delivered to Chemical Weapons Authority, Department of Trade and Industry, Kingsgate House, 66-74 Victoria Street, London

DEPARTMENT OF TRANSPORT

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of all-purpose highway and footpaths, north of the Plough Roundabout, Hemel Hempstead, Hertfordshire.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the outline planning permission granted to Eagle Star Properties Limited by the Secretary of State for the Environment on 23rd May 1996, under reference T/APP/A1910/A/95/261464/P5.

The proposed Order will require an improvement of the allpurpose highway known as Marlowes and the provision of a new highway maintainable at the public expense for which Hertfordshire Council will be the local highway authority. The proposed Order will provide that the stopping-up must not be carried out until Eagle Star Properties Limited has improved the all-purpose highway known as Marlowes and provided the new highway and that the new highway and the improved highway shall be highways maintainable at the public expense for which Hertfordshire County Council will be the local highway authority.

Copies of the draft Order and relevant plan may be inspected at all reasonable hours during 28 days commencing on 30th October 1996 at the offices of Dacorum Borough Council, Civic Centre, Hemel Hempstead, Hertfordshire and may be obtained, free of charge, from the Government Office for Eastern Region (Transport) (quoting reference GT/A1910/35/1/07) at the address stated below.

Any person may object to the making of the proposed Order within the period of 28 days commencing on 30th October 1996, by notice to the Secretary of State for Transport, quoting the above reference, at the Government Office for Eastern Region (Transport), Heron House, 49-53 Goldington Road, Bedford MK40 3LL.

In preparing an objection it should be borne in mind that the substance of it may be imparted to other persons who may be affected by it and that those persons may wish to communicate with the objector about it.
