PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-Line Works Authorisation

- (f) prohibit any person from loading or unloading their vehicle between the hours of 9.30 a.m. to 4 p.m. Monday to Saturday inclusive on parts of the road known as Oldbury Road.
- (g) no person shall cause or permit any motor vehicle constructed or adapted to carry more than 12 passengers (exclusive of driver) to proceed in that length of Mill Street which extends from its junction with the A38 Church Street throughout its whole length; except for:
 - (i) public service vehicles used in the provision of local services;
 - (ii) scheduled express services;
 - (iii) school buses; and
 - (iv) work buses.
- (h) create on street parking places for goods vehicles only in parts of the roads known as High Street and Mill Street.
- (i) to revoke the following Orders or parts of Orders:
Gloucestershire County Council (Town of Tewkesbury) (Various Roads) (Prohibition and Restriction of Waiting) Order 1982, Schedule 1, item 4(b)
Gloucestershire County Council (Various Roads, Tewkesbury) (Waiting Restriction) Order 1990, Schedule 1, item(s) Chance Street and Ropewalk

Gloucestershire County Council (Various Roads, Tewkesbury) (General Traffic Regulations) Order 1994 Schedule 1 item 9, Schedule 2 item 3(a) and 3(b); Schedule 3 item 5(b), and Schedule 4 items 1(a), 3 and 4.

The Kent County Council (Bus Stops Clearway) (Speldhurst Road, Southborough) Order 1996

Notice is hereby given that Kent County Council propose to make the above Order under sections 1(1) and (2); 2(1) to (3); 3(2) and 4(1) of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of the Schedule 9 to the Act.

The purpose of the Order is to prohibit vehicles, other than buses, from stopping or waiting between 7 a.m. and 7 p.m. on any day at any bus stop where the carriageway is marked with a bus stop box with a broad yellow line adjacent to the edge of the carriageway.
