

end of the quarter or, in the case of a marked increase in concentration or the identification of a pesticide not previously present, as far as is reasonably practicable, within 28 days of the sample being taken.

(b) Complete appraisal and determine treatment option. To be completed by 31st August 1996.

(c) Complete design and award contract. To be completed by 30th June 1997.

(d) Construction and commissioning of plant. To be completed by 30th April 1998.

(e) If pesticide concentration approaches or exceeds advisory value specified on pages 99 to 105 of "Guidance on Safeguarding the Quality of Public Water Supplies 1989" or notified by DWI;

(i) Provide DWI with information specified in (a), as soon as analytical results available, and so far as reasonably practicable, not more than 28 days of the sample being taken.

(ii) Notify EA as in (a), as soon as analytical results available, and so far as is practicable, not more than 28 days of the sample being taken.

(iii) Carry out further sampling and, if investigations show that pollution is of a long standing nature, consider the temporary provision of an alternative supply of potable water. To be completed as necessary.

(f) Report on progress of all the above steps [except (e)(i)] to DWI. Report to be given at least every 6 months.

4. is satisfied that Severn Trent Water Limited has given and is complying with an undertaking to take all such steps as appear to the Secretary of State for time being to be appropriate to secure or facilitate compliance with the requirement of Regulation 3(3)(c) of the Water Supply (Water Quality) Regulations 1989.

WATER INDUSTRY ACT, SECTION 19(1)(b)

Consumers in Salcombe and the surrounding area who might be affected by improvement work being carried out by South West Water Services Limited, at its West Alvington Service Reservoir, will wish to be aware of the following information.

The Company has found through its water quality monitoring programme that water supplied from this reservoir fails on occasion to meet the standard for total coliforms (as required by the Water Supply (Water Quality) Regulations 1989). These failures do not make the water unsafe to drink at any time. The Secretary of State for the Environment has notified the Company that he will, if necessary, order the Company to take appropriate steps to ensure that the water supplied will in future meet the required standard.

The Company has given the Secretary of State a legally binding undertaking to carry out appropriate remedial work at West Alvington Service Reservoir, to be completed by 31st March 1997. The Secretary of State has informed the Company that he is satisfied it is complying with this undertaking, by serving on them the following notice.

WATER INDUSTRY ACT, SECTION 19(1)(b)

The Secretary of State for the Environment:

- (1) is satisfied that South West Water Services Limited, "the Company" in supplying water from West Alvington Service Reservoir, is contravening, and is likely to do so again, its duty to supply wholesome water under Section 68(1)(a) of the Water Industry Act 1991, and the requirement of regulation 3(7) of the Water Supply (Water Quality) Regulations 1989, that water supplied should not contain total coliforms;
- (2) has notified South West Water Services Limited, on 7th May 1996, that he is considering making, in relation to the Company,

an enforcement Order under Section 18 of the Water Industry Act 1991;

- (3) notes that South West Water Services Limited has, on 10th October 1996, given an undertaking under Section 19(1)(b) of the Water Industry Act 1991, to take the following steps by the dates shown:

Carry out remedial works at West Alvington Service Reservoir as follows:

Isolate the Service Reservoir and remove the existing concrete roof and construct new roof. To be completed by 31st March 1997;

- (4) is satisfied that South West Water Services Limited has given, and is complying with an undertaking to take all such steps as appear to the Secretary of State for the time being, to be appropriate to secure or facilitate compliance with the requirement of Regulation 3(7) of the Water Supply (Water Quality) Regulations 1989.

NOTICE OF PUBLIC PATH ORDERS

The Rawmarsh Parish Public Footpath No. 24 Temporary Stopping-up Order 1997

The Rawmarsh Parish Back Lane Temporary Stopping-up Order 1997

Notice is hereby given that the Secretary of State for the Environment, in exercise of the powers conferred on him by sections 247, 253 and 261 of the Town and Country Planning Act 1990, and all other powers enabling him in that behalf, proposes to make two Orders the effect of which will be to temporarily stop up for a period of 4 years:

- (i) Public Footpath No. 24 running from Greasborough Lane in a north-westerly direction to Back Lane, Rawmarsh, Rotherham; and
- (ii) a section of Back Lane, an all-purpose highway, commencing at Greasborough Lane and proceeding in a northerly direction for 200 metres thence continuing in a north-north-westerly direction for 630 metres to its junction with Rig Lane, Rawmarsh, Rotherham,

if planning permission is granted by him to enable the extraction of minerals by surface working.

A copy of the draft Order and the map contained in it may be inspected, by any person, free of charge, at the office of the Secretary of State for the Environment, Government Office for Yorkshire and Humberside, Room 1107, City House, Leeds LS1 4US, and the Legal and Democratic Services of Rotherham Metropolitan Borough Council in the Civic Building, Rotherham, at all reasonable hours during a period of 28 days from Friday, 15th November 1996.

Any person may, within that period, object to the making of the Orders by notice in writing to the Secretary of State for the Environment, at the above address, quoting Ref. YH5097/151/10 and stating the grounds on which the objection is made.
