TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 247 and 261 of the above Act, to authorise the stopping-up of areas of highway and permanent diversion of the C107 and C114 (subject to the retention of lengths of footpath rights which are to be temporarily suspended for a period of 8 years). Also the temporary suspension for a period of 8 years of lengths of Footpath Number 2, Footpath Number 3 and Footpath Number 5, also the temporary diversion of Footpath Number 4 at or within the vicinity of West Chevington, Maidens Hall and Bullocks Hall in the county of Northumberland.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to R. J. B. Mining (UK) Ltd. by Northumberland County Council on 1st June 1996, under Ref. 94/CC/78.

The Proposed Exmouth Docks Harbour Revision Order

Notice is hereby given that a public inquiry in connection with the proposed Exmouth Docks Harbour Revision Order will be held by W. J. Bingham (a person appointed by the Secretary of State for that purpose), at The Pavilion, Esplanade, Exmouth, commencing on Tuesday, 18th February 1997 at 10 a.m., when representations from persons who have objected to the draft Order, and from any other persons who wish to appear, will be heard.

A one day pre-inquiry Meeting will take place on Wednesday, 8th January 1997, at the same venue.

The object of the proposed Order is to provide for the partial closure of Exmouth Docks by altering the limits of jurisdiction of the Exmouth Docks Company and restricting the handling of certain cargoes. The Order also makes provision as to the levying of certain dues, and repeals certain spent or obsolete provisions of the Exmouth Docks Acts and Orders 1864 to 1968.
